

Dear Company Representative or Owner:

The City of Dallas Chapter 43A -17(a) states that "A person shall not operate a public or semi-public pool without a permit. To obtain a permit an applicant must complete a form provided by the director. An applicant must designate a manager of operations of each pool for which a permit is sought. A person designated as manager of operations of a pool must reside in the city or be employed on the premises where the pool is located". Pool owners operating a pool/spa without a permit are subject to having the pool/spa closed and being issued a citation. Any pool/spa(s) are to remain closed until a permit is obtained.

The amount of the fee is \$175 for the first pool owned by an applicant at one location, plus \$100 for each additional pool/spa owned by the applicant at the same location. Fees for new and renewed pool/spa permits are due on or before the first day of March of each calendar year. If a permit is initially issued after the first day of March of a calendar year, the fee for that year will be prorated according to the number of whole months remaining in the year.

Please return the completed application(s), a copy of the "Manager of Pool Operators Certificate", issued by the City of Dallas, (if your certificate is valid and has not expired), with the appropriate payment made payable to the City of Dallas for the number of pool/spa(s) at a given location.

<u>Please note</u>: An application form must be completed for each location.
