BACKGROUND

This item is being placed on the addendum to expedite the public hearing and 30-day public comment period required by federal regulation and the City's Citizen Participation Plan. The approval will assist the City in meeting its expenditure requirement for the use of federal funds from the U.S. Department of Housing and Urban Development ("HUD").

On May 24, 2017, City Council authorized the preliminary adoption of the Proposed FY 2017-18 Consolidated Plan Budget for HUD Grant Funds, including FY17 ESG funds, in the preliminary amount of \$1,211,466.00, by Resolution No. 17-0848.

On June 14, 2017, HUD published the final grant allocations for the FY 2017-18 Consolidated Plan Budget for HUD Grant Funds, including the actual FY17 ESG grant allocation in the amount of \$1,193,613.00. On June 23, 2017, City Council was briefed by memorandum on the final grant allocations. By letter dated June 30, 2017, HUD notified the City of Dallas that it would receive an FY17 ESG Supplemental Allocation in the amount of \$1,923,927.00, for a total FY17 ESG allocation of \$3,117,540.00.

On August 9, 2017, City Council authorized the final adoption of the FY 2017-18 Consolidated Plan Budget for HUD Grant Funds, including FY17 ESG funds in the amount of \$3,117,540.00, by Resolution No. 17-1171.

On September 14, 2017, the City of Dallas Office of Procurement Services advertised a Request for Competitive Sealed Proposals ("RFCSP") (#BTZ1726) soliciting proposals for the FY 2017-18 ESG Program funded using FY17 ESG funds. On December 13, 2017, by Council Resolution No. 17-1874, the proposals were rejected and authorization to re-advertise a solicitation was granted.

On January 11, 2018, the City of Dallas Office of Procurement Services re-advertised an RFCSP (#BTZ1810) soliciting proposals for the FY 2017-18 ESG Program. Eleven provider contracts were awarded funding for Emergency Shelter, Rapid Re-housing, and Homelessness Prevention activities, in the amount of \$1,413,895.00.

On June 7, 2018, the City of Dallas Office of Procurement Services advertised an RFCSP (#BTZ1818) for ESG Facility Development funds, in the amount of \$1,000,000.00. Three providers were awarded and accepted funds for facility development, consisting of shelter renovations, in the amount of \$265,011.00.

On January 31, 2019, the City of Dallas Office of Procurement Services advertised a fourth RFCSP (#BKZ1909) for FY17 ESG funding in the amount of \$734,989.00. Four providers were awarded funds for emergency shelter activities in the amount of \$734,989.00. Proposers are required to match ESG funds dollar-for-dollar. The match total must equal or exceed the amount of ESG funds awarded.

On April 10, 2019, City Council authorized Reprogramming Budget No. 1 (Substantial Amendment No. 1) to the FY2018-19 Action Plan to use unspent prior year Community Development Block Grant ("CDBG") funds by Resolution No. 19-0556.

On April 24, 2019, City Council authorized the preliminary adoption of Substantial Amendment No. 2 to the FY2018-19 Action Plan for HOME Investment Partnerships Program and CDBG to revise the Dallas Homebuyer Assistance Program Statement and the Housing Improvement and Preservation Program Statement by Resolution No. 19-0639. The public hearing on Substantial Amendment No. 2 is scheduled to be held on June 26, 2019.

FY17 ESG funds must be expended within 24 months after the date HUD signed the grant agreement with the City of Dallas, which is October 19, 2019. Spending the additional special \$1.9 million FY17 ESG Supplemental Allocation (over and above our normal annual allocation of approximately \$1.2 million) has proved challenging. The Dallas housing market conditions, along with specific program requirements, such as the dollar-for-dollar match requirement, have been exacerbating factors. The Office of Homeless Solutions has been working with ESG partners to mitigate challenges. However, it is necessary to reallocate FY17 ESG funds among eligible activities to meet the expenditure deadline.

Federal regulations and the City's Citizen Participation Plan require a public hearing to authorize a substantial amendment and require that a public hearing be held with not less than a 30-day public review and comment period to allow for public comments and input with respect to any substantial amendment.

BACKGROUND

This item is placed on the addendum due to late award notification and must be approved before receiving funding.

The City of Dallas Police Department (DPD) has been awarded funding to reduce crime and improve the criminal justice system under the state criminal justice planning grant.

The NIBIN Program allows federal, state, and local law enforcement agencies to find linkages between crimes quickly and to make connections in crimes across jurisdictional boundaries. The Dallas Police Department has found and confirmed over 2100 NIBIN leads to date offering valuable information for detectives to help solve firearm related crime. The grant will partially fund the salary of one certified Police Officer within the Crime Scene Response Section to support data entry and analysis in the NIBIN Program. The grant also funds training and equipment.

DPD currently houses approximately 50,000 firearms and receives about 750 new firearms and cartridge casings from crime scenes each month. Most meet the criteria for entry into the NIBIN database and the full time Police Officer will continue to process valuable evidence and work to reduce the growing backlog.

The In-Kind Contributions covers Pension, Health Benefit, Federal Insurance Contributions Act and remaining salary for the officer.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On November 12, 2014, City Council authorized application and acceptance for the City of Dallas National Integrated Ballistic Information Network Grant No. 2408205, by Resolution No. 14-1911.

On October 28, 2015, City Council authorized application and acceptance for the City of Dallas National Integrated Ballistic Information Network Grant No. 2408206, by Resolution No. 15-1959.

The Public Safety and Criminal Justice Committee will be briefed by memorandum regarding this matter on June 21, 2019.

FISCAL INFORMATION

Office of the Governor, Criminal Justice Division Grant Funds - \$71,975.00 In-Kind Contributions - \$75,257.32

WHEREAS, the U.S. Department of Justice pass through Office of the Governor, Criminal Justice Division has made funds available for criminal justice projects for the 2018-2019 fiscal year; and

WHEREAS, the increased program and funding source would benefit the City of Dallas in its endeavor to reduce crime and improve public safety; and

WHEREAS, the City of Dallas finds it in the best interest of the citizens of Dallas that the Office of the Governor, Criminal Justice Division be operated for the 2018-2019 fiscal year; and

WHEREAS, the City of Dallas agrees that in the event of loss or misuse of the Criminal Justice Division funds, the City of Dallas assures that the funds identified as ineligible will be returned to the Criminal Justice Division; and

WHEREAS, the City of Dallas designates the City Manager or an Assistant City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate a grant on behalf of the applicant agency; and

WHEREAS, it is in the best interest of the City of Dallas to accept such funding.

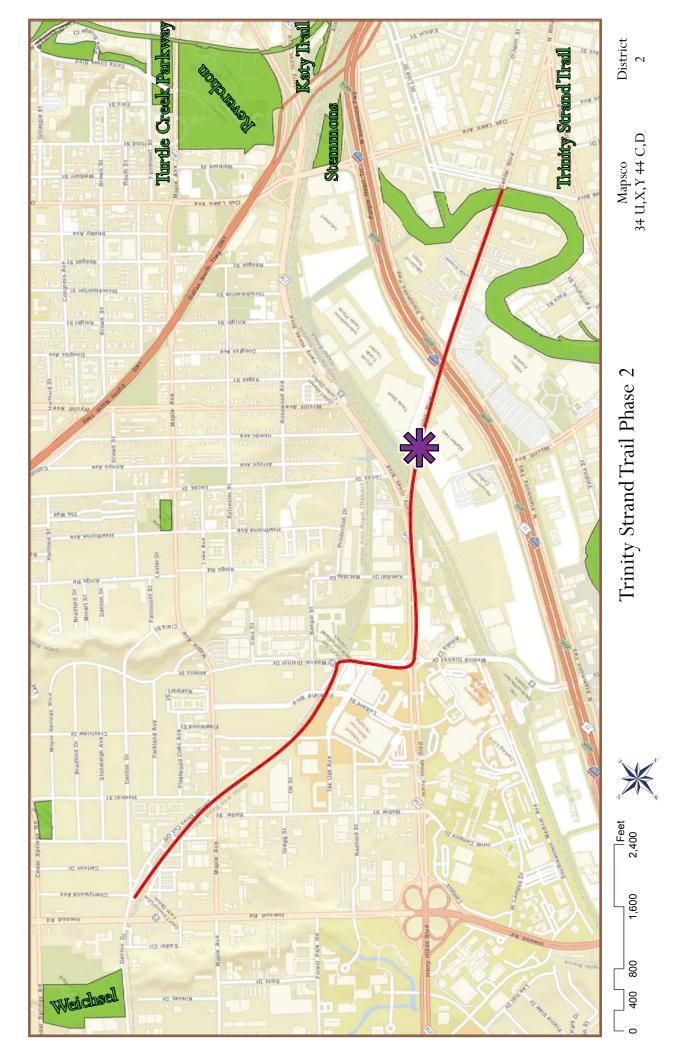

BACKGROUND

The Passenger Facility Charge (PFC) Program is a federally authorized, local charge to provide capital funding for eligible airport projects. Eligible projects include those that preserve or enhance safety, security, or capacity; reduce noise or mitigate noise impacts per standards; or enhance competition. The PFC is collected by the air-carriers from boarding passengers through each ticket sale and remitted to the airport. Current legislation allows a PFC ranging from \$1.00 up to \$4.50 per eligible enplaned passenger. The City Council previously authorized the City Manager to apply for authorization to collect a PFC at the rate of \$4.50 per enplaned passenger.

On May 13, 2009, City Council authorized the City Manager to apply for authorization to collect a PFC at the rate of \$4.50 per enplaned passenger by Resolution No. 09-1224.

The City Council is asked to approve a new PFC Application No. 5 whereby the City will ask the Federal Aviation Administration (FAA) to authorize the City's collection of \$142,522,322.00 for twelve new capital improvement projects at Dallas Love Field. If Application No. 5 is approved by the FAA, the \$4.50 collection rate will continue until June 2027 the full amount of \$142,522,322.00 has been collected.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On August 24, 2011, City Council authorized PFC Application No. 4 and an amendment to the PFC Application No. 3, by Resolution No. 11-2160.

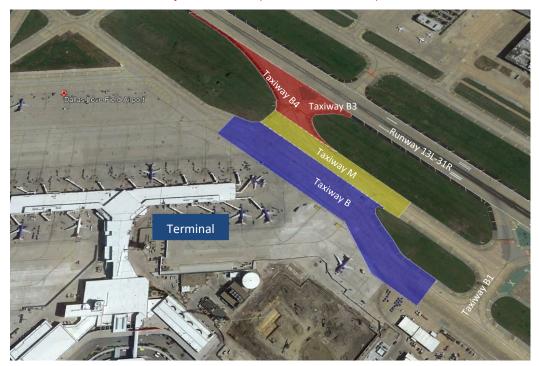

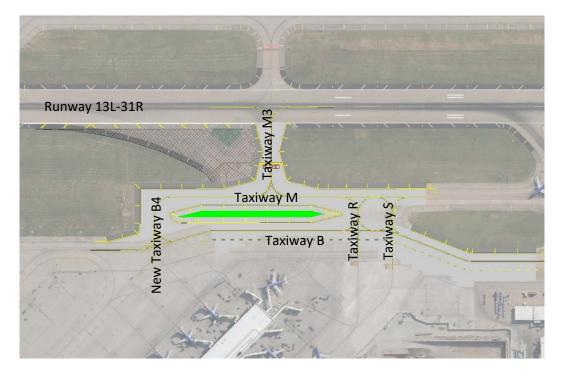

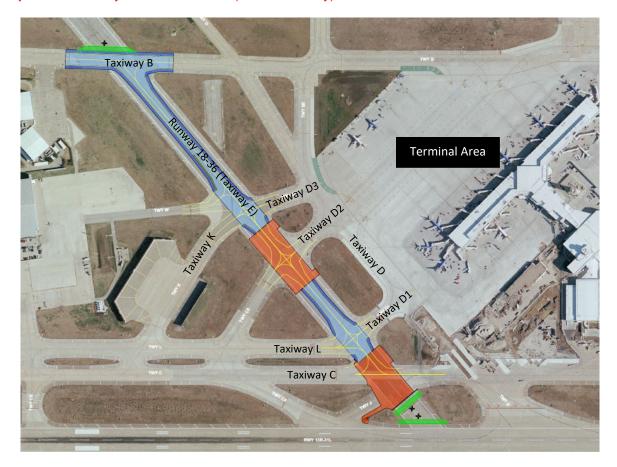
Project 5.01 Reconstruction Taxiway B - Phase 1 (before construction)



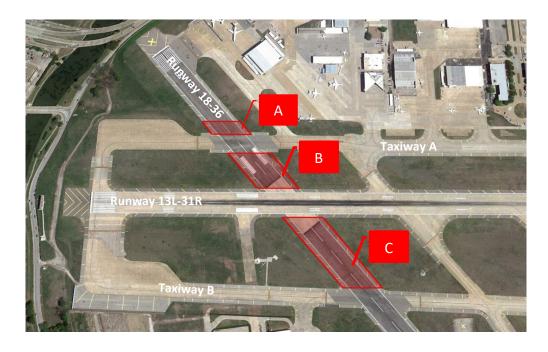

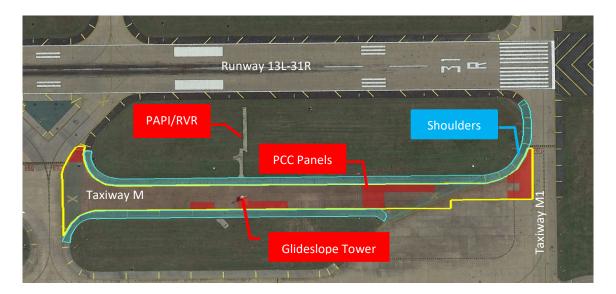

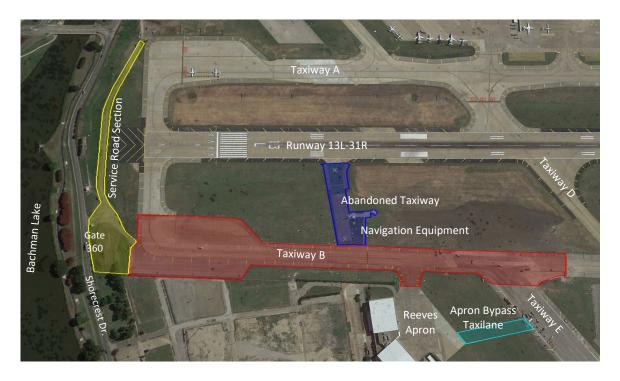

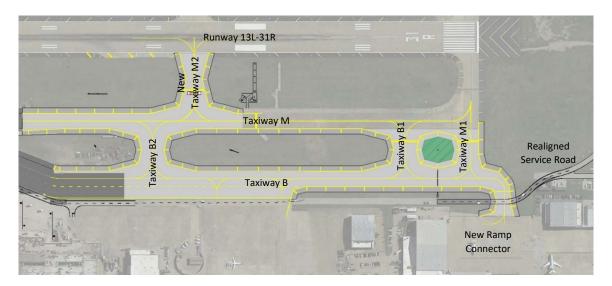

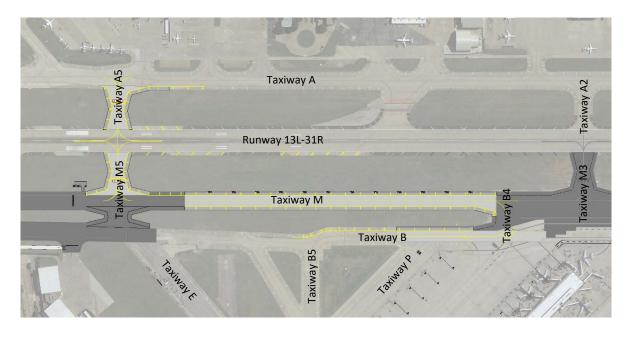

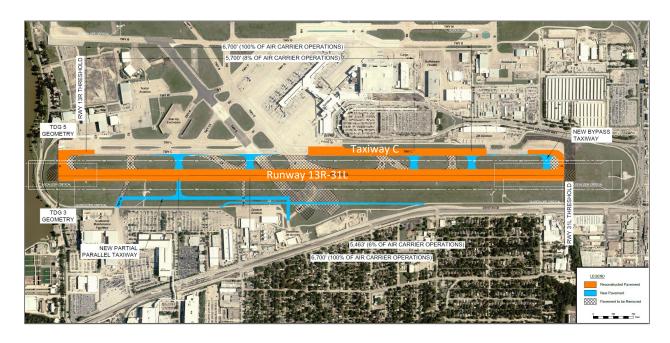

WHEREAS, the twelve proposed projects under PFC Application No. 5 are listed on the attached **Exhibit A**.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to apply for a Passenger Facility Charge Application No. 5 to the Federal Aviation Administration to provide funding for twelve new capital improvement projects at Dallas Love Field, in the estimated revenue amount of \$142,522,322.00.

SECTION 2. That if Application No. 5 is approved by the FAA, the \$4.50 collection rate will continue until June 2027 the full amount of \$142,522,322.00 has been collected.

SECTION 3. That the Chief Financial Officer is hereby authorized to deposit all PFC revenues received into the Aviation Passenger Facility Charge Fund, Fund 0477, Department AVI, Unit 0781, Revenue Code 781H.

SECTION 4. That the Chief Financial Officer is hereby authorized to transfer funds from Fund 0477, Dept. AVI, Balance Sheet Account 0001 (cash account), to Aviation's future Capital Improvement Program project funds; Department AVI, Balance Sheet Account 0001, on an as needed basis.

SECTION 5. That this resolution shall take effect immediately from and after its passage, in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
