SUBJECT: **Update Regarding the Deadly Attack on Police Officers**

On July 7, 2016, at the conclusion of a protest/rally, shots were fired, and initially it was believed that two snipers shot multiple police officers from elevated positions. At 10:24 p.m. it was reported that three officers were deceased, two were in surgery, and three in critical condition. No suspects were in custody, an intensive search was underway, and citizens were asked to call with any information.

At 10:48 p.m. it was reported that 11 officers had been shot during an exchange of gunfire with one of the suspects. A picture of a person of interest was pushed out to the media asking for assistance in making identification. This person of interest, later identified as Mark Hughes, turned himself in, was interviewed and released.

At 11:19 p.m. it was announced a fourth officer was deceased.

Officers continued to search for the suspect. A suspect was located and became involved in a shootout with SWAT officers. The suspect was inside El Centro and had positioned himself in an area that didn't allow officers to get any closer to the suspect without exposing themselves to gunfire. It was also reported a suspicious package was located near the suspect. Negotiators attempted to talk the suspect in to giving himself up but the suspect refused. Officers ultimately attached an explosive device to a robot and detonated it near the suspect. The suspect was then incapacitated and ultimately died.

On July 8, 2016, the fifth officer passed away. This brought the total count to one deceased and three injured Dart Officers and four deceased and four injured Dallas Officers.

Currently detectives have interviewed over 200 officers and it appears at least 12 have discharged their duty weapons. Resources from the Bureau of Alcohol, Tobacco, Firearms, and Explosives, Federal Bureau of Investigations, U.S. Marshals, Homeland Security and Investigations, Drug Enforcement Administration, Department of Public Safety, Texas Rangers, Dallas Area Rapid Transit, Dallas County District Attorney's Office, and the Dallas County Sheriff's Department are all assisting with the investigation, the processing of evidence and crime scene locations. Portions of the crime scene locations in the downtown area will remain closed to the public until Wednesday.

The deceased suspect has been identified as Micah Johnson B/M/25. He has no criminal history, and information obtained through the course of the investigation indicates he was an Army veteran, and others identified him as a loner. The suspect's Facebook account included the following names

and information: Fahed Hassen, Richard GRIFFIN aka Professor Griff, GRIFFIN embraces a radical form of Afrocentrism, and GRIFFIN wrote a book A Warriors Tapestry.

During the search of the suspect's home, detectives found bomb making materials, ballistic vests, rifles, ammunition, and a personal journal of combat tactics. Detectives are in the process of analyzing the information contained in the journal.

In addition, Brandon Waller B/M/25 was arrested for unrelated weapons charges at the scene on July 7, 2016.

SUBJECT Moody's Investors Service – Annual Review of City of Dallas General Obligation Bond Rating

On June 27th, Moody's Investors Service requested a meeting with City staff be scheduled before the end of July to discuss the City's Comprehensive Annual Financial Report (CAFR) for fiscal year 2015. Subsequent communication from the agency makes clear that this meeting will serve as the first step in Moody's annual surveillance review, which is designed to assess whether an issuer's current assigned rating and rating outlook are appropriate.

Moody's will be conducting a full review of the City's rating, which means that information requests and analyses will continue after the July meeting until the rating analyst is ready to make a recommendation to the rating committee. Moody's internal rating committee will ultimately determine whether the current Moody's rating of Aa2 with a stable outlook is either confirmed or changed as a result of the surveillance process. A memo with the committee's decision will be sent once Moody's notifies the City of its decision.
