To The Honorable Chair and Members of the Charter Review Commission
Subject Boards and Commissions Information Requested

Noted below is information you requested at your March 4 and March 11 meetings. Boards and Commissions (B&C) are governed by Chapter 8 and Chapter 12A (Ethics Code) of the Dallas City Code. These chapters can be found by accessing the Dallas City Code at http://www.amlegal.com/dallas_tx/ and viewing the applicable chapter.

- B&C Meetings

- City Code, Chapter 8, Section 8-2 (Regular Meetings), states, "Each board shall determine the time and place of its meetings. Regular meetings shall be scheduled weekly, monthly, semi-monthly, or quarterly, as the responsibilities of the board necessitate, at a location within a public building."
- City Code, Chapter 8, Section 8-3 address special meetings. As special meetings do not affect attendance, this section is not specifically covered.

- B&C Attendance and/or Forfeiture

- City Charter, Chapter 24, Section 17 (Board and Commission Members), Subsection (a) states, "Other than members of the city council, no person shall be appointed to more than two permanent boards or commissions of the City of Dallas at any one time. Any member of any commission or board appointed by the city council shall forfeit that office if the member misses more than three regular meetings in succession, unless for medical reasons certified to by a physician or unless excused by the board or commission of which he or she is a member and the city council. In such case, the city council shall declare the position vacant and appoint a new member to fill the vacancy."
 - *As you know, the City Attorney's Office discussed with you the proposed amendment to Chapter 24, Section 17 of the Dallas City Charter and provided the recommended verbiage which allow for the forfeiture to be in accordance to the Dallas City Code [Chapter 8-20 as noted below].*
- City Code Chapter 8-20 (Attendance) states, "**(a)** No member shall be excused from attendance at a board meeting, unless for medical reasons certified to by a physician or unless excused by the board and the city council. A member having three unexcused absences in succession shall forfeit membership on the board. **(b)** A member of a board that meets weekly or biweekly, who is absent from more than 25 percent of the regular meetings in any six month period, whether excused or not, shall forfeit membership on the board. **(c)** A member of a board that meets monthly, who is absent from more than 25 percent of the regular meetings during any 12 month period, whether excused or not, shall forfeit membership on the board. **(d)** An office that has been forfeited under the provisions of this section shall be filled for the remainder of the term by appointment of the city council. **(e)** For purposes of this section, the record of a member's absences will begin with the first regular meeting after the 15th day from the date the member received notice of appointment."

- *The most controversial issue regarding forfeiture is the “absent more than 25% of the regular meetings” [Section 8-20(b) and (c) above]. Calculation under this rule is based on using the total number of actual regular meetings held in a 12-month period preceding the currently reported meeting and the number of absences from the total regular meetings held. See examples below:*
 - *Board that meets biweekly: An attendance report on March 2014 meeting could show 11 regular meetings held from the previous six months (October 2013 through March 2014). If a member is absent from two of those meetings, the absences equate to 18%. Three absences during the period would constitute 27%. [$2/11 = .18 \times 100 = 18\%$, etc.]*
 - *Board that meets monthly: An attendance report on March 2014 meeting could show 11 regular meetings held from the previous 12 months (February 2013 through March 2014). If a member is absent from two of those meetings, the absences equate to 18%. Three absences during the period would constitute 27%. [$2/11 = .18 \times 100 = 18\%$, etc.]*
 - *Board that meets quarterly: Not applicable as not covered under the City Code.*
- *Individuals are advised they can contact the council member who appointed them and seek reappointment. It is quite common for the individuals to seek and be reappointed. There have been instances where the individuals have not sought reappointment. If reappointing an individual who was forfeited for attendance issues, the council member must make a statement for the record regarding the previous attendance issue. The City Council has always reappointed these individuals.*
- City Code, Chapter 8, Section 8-20.1 (Special Attendance Requirements), states, “If a board or commission, as part of its decision-making process, schedules an inspection trip to the location of a matter that is to be considered by the board or commission at that day’s meeting, a member will be counted absent unless: (1) the member attends both the inspection trip and the meeting; or (2) the member represents that a personal inspection has been made of each location visited by the inspection trip and attends the meeting.”
 - *This type of unexcused absence will apply to forfeiture under the rules noted earlier. However, records don’t show an absence was ever related to this issue.*
- City Code, Chapter 8, Section 8-21 (Excusal During Meeting), states, “A member may not leave a board meeting in regular session without acknowledgement by the chair. A member who leaves a board meeting after the board has been duly called to order and is absent for the remainder of the meeting, without first obtaining the consent of the chair, shall be charged with an unexcused absence for that meeting. The consent of the chair may be given only in an emergency beyond the control of the member that requires the member to leave the meeting.”
 - *This type of unexcused absence will apply to forfeiture under the rules noted earlier. However, records don’t show an absence was ever related to this issue.*
 - *As was raised by a citizen at one of your community meetings, tardiness is not addressed in the code. The advice provided is that the board may wish to address this issue by adopting (or amending) its own rules of procedure; but ultimately, the determination of attendance being affected for consistent tardiness would be up to the City Council as the board does not have forfeiture authority.*
- City Code, Chapter 8, Section 8-1.2 (Notice of Appointment; Acceptance), Subsection (b), states, “The appointee must return the signed acceptance of appointment to the city secretary within 15 calendar days from the date of receiving notice of the appointment. If the city secretary does not receive the signed acceptance of appointment within the required 15 days, that board position shall be considered vacant and a new appointment made.

- *Forfeitures for failing to return the paperwork under this section has occurred, although not very often. In some instances, the individual seeks reappointment, while in other instances, they do not. These documents include the Oath of Office and Oath of Appointed Officer and Financial Disclosure Report (initial report) if required.*

- **B&C Membership**

- Attached are several reports which contain specific information requested outside of the absence/forfeiture policy.

Provides general information on board service, terms, qualifications, individual/full council appointee totals and chair/vice chair appointments.
 - ✦ **General Qualifications & Special Requirements**
General qualifications are as follows:
 - Be a resident of Dallas for six months
 - Be a qualified voter at time of appointment
 - Have no criminal record is considered by city council to be so serious that it should be a disqualification
 - Generally, not be an adversary party to pending litigation against the city
 - Not be in arrears on any city taxes, water service charges or other obligations owed the city
 - Have credible record of attendance and performance in any previous board service
 - Continually in compliance with the City Charter and Chapter 12A of the Dallas City Code at initial appointment and throughout their service*The report provided outlines special requirements for certain boards/commissions.*
 - ✦ **B&C Listing, Classification and Identification**
Presents a list of city boards/commissions and a snapshot of board/commission type and term of service.

**CITY OF DALLAS
BOARDS AND COMMISSIONS
FACT SHEET**

- Most board terms are two years, beginning October 1 of odd-numbered years.
- During September of each odd-numbered year, the City Council shall appoint all members of the commissions and boards provided for in this Charter or which the City Council may provide for by ordinance.
- A board or commission member may serve no more than four consecutive two-year terms on the same board or commission. One day more than 365 is considered a term.
- Other than members of the city council, no person shall be appointed to more than two permanent boards or commissions of the City of Dallas at any one time. *Note, Reinvestment Zone Boards/Tax Increment Finance Boards and Municipal Management Districts are not classified as permanent boards.
- A board or commission member must be a resident of the City of Dallas (except reinvestment zone board members), must be a registered voter, and must be current in payment of city taxes, fees, and other obligations owed the city at time of appointment and throughout term(s) served.
- Currently there are **52** boards and commissions to which the City Council appoints some or all of the members. There are **2** boards and committees to which the City Manager nominates and the City Council appoints. There is **1** board appointed by the Mayor (Dallas Housing Authority Board).
- Each member of the City Council will have **16** "Individual" appointments to city boards and commissions. The "individual" appointments are subject to confirmation by the full City Council.
- The City Council will make **197** "full-council" appointments to boards and commissions. Any council member may nominate a person to fill a "full-council" position.
- The Mayor appoints the chair, subject to confirmation by a majority of the City Council, and the City Council appoints the vice chair of most boards and commissions.

CULTURAL AFFAIRS COMMISSION – 18 MEMBERS
3 ALTERNATE MEMBERS FULL COUNCIL APPOINTMENT
(DALLAS CITY CODE, SECTION 2-161)

ADVISORY

There is hereby created the cultural affairs commission of the city, which shall be an advisory body of 18 members appointed by the city council. Fifteen of the members shall be appointed respectively by each city council member, and three of the members shall be appointed by the city council as a whole.

Members of the commission should be persons who are concerned about cultural affairs in the city of Dallas and may be persons who have professional expertise or substantial volunteer involvement in the following areas: (1) architecture, design, or urban planning; (2) visual, performing, or literary arts; (3) history; (4) science; (5) cultural institutions management; or (6) volunteer cultural board experience.

The membership of the cultural affairs commission may include at least one of each of the following persons: (1) a registered professional architect or landscape architect; (2) professional visual artist; (3) professional performing artist; (4) scientist; (5) historian; (6) an interested citizen who does not represent any specific cultural organization or interest group.
