Authorize an application for the National Recreation and Park Association (NRPA) Climate Resiliency Grant program in the amount of \$100,000.00 to expand the Green Strike Team's Maintenance Project at parks in downtown Dallas. - Financing: no cost consideration to the City

BACKGROUND

NRPA administers the Climate Resiliency Grant Program and is the leading not-for-profit organization dedicated to building strong, vibrant and resilient communities through the power of parks and recreation. NRPA advances this vision by investing in and championing the work of park and recreation professionals as a catalyst for positive change in service of equity, climate-readiness, and overall health and well-being. The NRPA Climate Resiliency Program does not require a match.

The Dallas Park and Recreation Department established a Green Strike Team that exclusively uses electric (lithium battery-powered) hand-held landscaping equipment, including backpack blowers, hedge trimmers, small chainsaws, and line trimmers. The Green Strike Team has been maintaining downtown Dallas parks for four years. Dallas is a nonattainment area for the air pollutant, ground level ozone. The department committed to this sustainability initiative to reduce emissions produced by fuel powered hand-held equipment since electric equipment emits no pollution and will eliminate pollutants that contribute to ground level ozone and climate change. The use of electric equipment strives to create a park environment that is clean, safe, and healthy.

The Dallas Park and Recreation Department is proposing to expand the Green Strike Team equipment to include three electric mowers, a Mean Green Zero Turn mower and two Toro grand stand mowers. The addition of electric mowers will eliminate additional air pollutants while downtown parks are being maintained. When the Green Strike Team was established, commercial electric mowers were not available. Over the past 4 years, technology has advanced and there now are commercial electric mowers that meet the Park Maintenance Operation's needs for maintaining downtown parks that includes batteries that operate for 6 to 8 hours per charge. SUBJECT

Authorize an application for the North American Wetlands Conservation Act (NAWCA) Fund - Small Grant program in the amount of \$100,000 from the U.S. Fish and Wildlife Service for the Hines Park Wetlands Project, located at 9601 Harry Hines Boulevard - Financing: no cost consideration to the City.

BACKGROUND

The U.S. Fish and Wildlife Service administers the NAWCA Small Grant. Funding for this program supports public-private partnerships carrying out projects in the United States that further the goals of the North American Wetlands Conservation Act. These projects must involve long-term protection, restoration, and/or enhancement of wetlands and associated uplands habitats for the benefit of all wetlands-associated migratory birds. It is a competitive, matching grants program.

Hines Park is a 13.6-acre Conservancy Park, that was established in 2000 in Northwest Dallas. Hines Park is identified by the Dallas Park and Recreation Department as the candidate for this funding application due to its unique wetland that has developed, naturally over the last two decades, and supports over 28 species of birds, four species of waterfowl, three species of amphibians, and 102 species of native plants as identified through i-Naturalist and BioBlitz events recently held at the park.

The Dallas Park and Recreation Department intends to restore and enhance conditions at Hines Park that will help maintain the natural features of this critical wetland pond located within the park boundaries. The department's restoration activities will include removal of the nutria that have damaged existing waterflow, the addition of an inlet water pipe, and planting of native shoreline flora for erosion control.

BACKGROUND

On June 25, 2003, the City entered into a multi-year agreement with Texas Discovery Gardens (a non-profit organization) to manage and operate the Discovery Gardens building and surrounding grounds at Fair Park for a ten-year period. The agreement was extended on November 7, 2013 for a ten-year period. The agreement with Texas Discovery Gardens requires the execution of a separate funding contract to authorize the stipends payable during the current year.

On October 24, 2018, City Council authorized a management contract with Fair Park First for management and operation of Fair Park for the Park and Recreation Department for a term of twenty years, with two five-year extension options by Resolution No. 18-1531, which included an assignment of the underlying agreement with Texas Discovery Gardens to Fair Park First. However, the assigned contract does not contain a funding provision for community outreach and other related programming services.

On June 9, 2021, City Council authorized the first supplemental agreement with Fair Park First, to amend the agreement in the interest on enhancing, promoting and improving Fair Park by Resolution No. 21-1017, which included that the City shall be solely responsible for funding any operating grants, utility reimbursements, and other annual subsidies including any annual stipends.

For FY 22-23, Texas Discovery Gardens requested \$145,862, but this amount was not awarded via the City's budget allocation process. \$138,569 have been identified and appropriated in the City's General Fund by authorization of the City Council, and after the approval by the Park and Recreation Board for the current fiscal year.

BACKGROUND (continued)

The current Texas Discovery Gardens management agreement, which is overseen by Fair Park First, expires October 31, 2023. In order for the funding agreement to pair with the remaining period of the contract, this funding agreement will be prorated, for a total amount of \$115,474.20

This is a recurring annual funding agreement.

The stipend payment will support the following programs and services for period of January 1, 2023 through October 31, 2023:

Operate the Texas Discovery Gardens building and surrounding grounds at Fair Park for ten (10) months, providing access to the general public and community outreach services such as enrichment classes for school children, horticulture information services, and presentations at community centers and special facilities.

Park Board approval of the funding agreement is being requested.

BACKGROUND

On March 9, 2005, the City of Dallas, through its Park and Recreation Board and City Council, adopted Resolution No. 05-0950, entering into a twenty (20) year management agreement commencing on March 9, 2005 and ending on March 9, 2025 with two five (5) year renewal options, which authorizes National Audubon Society, Inc. (Audubon) to operate the Audubon Center and for Audubon to promote conservation education, including an understanding of the ecology and environmental issues of Texas and the Dallas area.

On July 13, 2018, per Administration Action No. 18-6208, the parties entered into a Supplemental Agreement which clarified and amended 1) Sections 5, substituting the old governance guidelines with new guidelines and 2) Section 9, changing 60 to 120 days for submittal of financial activities to the City.

The parties now desire to enter into a Supplemental Agreement #2, to clarify the remaining funding payments and to add performance standards.

SECTION 7.10 NON-DISCRIMINATION

BACKGROUND

On December 13, 2017, the Park and Recreation Board and the City Council adopted Resolution No.17-1886, entering into a multi-year agreement with Dallas United Crew, Inc. to design, develop, construct, operate, and maintain a portable equipment shelter and conduct rowing, kayaking, dragon boating, and other oar and paddle sports at White Rock Lake. The purpose of that shelter is to store rowing, kayaking, dragon boats and other oar and paddle sports. The agreement commenced on December 13, 2017, and ending on December 12, 2022, with two (2) five-year renewal options. The agreement requires Park Board approval and consent for this first five-year renewal.

The agreement requires DUC to pay the City an annual amount of \$6,100. Park and Recreation Board approval of the first renewal is being requested.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On December 13, 2017, City Council authorized a five-year management agreement with two (2) five-year renewal options for the construction, operation, and maintenance of a portable equipment shelter with Dallas United Crew for the period of December 13, 20, 2017 through December 12, 2022, by Resolution No. 17-1886.

BACKGROUND

This action does not encumber funds; the purpose of a service price agreement is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This service price agreement will be used to lease two (2) portable office buildings with the dimensions 14'x48' and 28'x64' respectively. These portable office buildings will serve as workspace for Park and Recreation staff under Park Maintenance Operations. The service price agreement will include the delivery, installation, dismantling and removal of the portable office buildings at the designated locations.

The Contractor will also be responsible for the repair and maintenance of the buildings during the contract term. In addition, the service price agreement will provide the Park and Recreation Department with the option to purchase the portable office buildings at the end of the thirty-six (36) month lease period.

The Texas Association of School Boards (BuyBoard) cooperative agreement is authorized by Chapter 791 of the Texas Government Code and Subchapter F, Chapter 271, Texas Local Government Code. Section 271.102 of the Texas Local Government Code authorizes a local government to participate in a Cooperative Purchasing Program with another local government or a local cooperative organization.
