





BACKGROUND

This item authorizes the acquisition from Clearview Investments, Ltd. of approximately 4.59 acres of land (Property) located at 6251 Mapleshade Lane for development of a future park (Exhibit A). The total purchase price for this acquisition is \$2,350,000.00 based on an independent appraisal (\$2,336,500.00 plus closing costs and title expenses not to exceed \$13,500.00).

This property is adjacent to the planned Timberglen Trail/Preston Trail Connection which is currently under design. The Property consists of two parcels of undeveloped land primarily covered by upland and low-land forest. McKamy Branch runs along the eastern boundary of the Property providing riparian habitat.

The acquisition of the Property will fill a parkland gap and provide parkland to nearby residents. Frankford Park is the nearest parkland, located over one-half mile away.

Staff recommends approval of this acquisition with the condition that this property is not officially dedicated as municipal parkland until such time as the entire property is developed for its intended use.





Authorize a supplemental Agreement to the golf-pro concession contract between the City of Dallas and IAMJ Enterprises, Inc., who manages the Cedar Crest Golf Course, located at 1800 Southerland Avenue –Not to exceed \$754,891.00 – Financing: General Funds (\$534,891.00), Multi-Year Funds (\$220,000.00)

BACKGROUND

Cedar Crest Golf Course, located at 1800 Southerland Avenue, is one of five full-service golf courses owned by the City of Dallas. The Park and Recreation Department (PKR) utilizes a public/private partnership to manage and operate the City's golf courses which operate year-round. The pro shop operations at Cedar Crest Golf Course are managed by certified golf professional, IAMJ Enterprises, Inc., through a contract with the City. The golf professional is also responsible for managing, operating, staffing, programming, and marketing the facility at his own expense. Programming includes tournaments, leagues, lessons, merchandising, and concessions. PKR personnel maintain the grounds of Cedar Crest Golf Course. Cedar Crest Golf Course averages 35,000 rounds of golf annually while producing over \$619,000 in annual revenue on average (general fund and multi-year fund). City of Dallas golf course facility and grounds operations are managed through city forces and the business operations are managed by private contractors who are PGA Professionals. This public/private contractual partnership maximizes the revenue potential and return on investment for both the operator and the City of Dallas.

Cedar Crest Golf Course has experienced an infestation of Poa Annua, an invasive and chemically resistant turfgrass pest, within the greens. This infestation caused difficulty in growing and maintaining adequate turf coverage on the course greens which in turn negatively impacted the playing surface and thus decreasing customer satisfaction with the product. In an effort to combat this infestation, staff and the golf professional decided to close the course for two weeks to over-seed the greens with the intent being to provide a quality putting surface until the Bermuda grass began to grow. Unfortunately, this action

did not address the infestation and the turf conditions continued to decline. Park Department golf course maintenance staff contacted turf specialists and agronomists in the region to develop a plan to replace the greens over a three-month period. This plan required the closure of the golf course beginning July 1, 2022, and then a series of actions were taken in order to remove the infected turf and replant with Tif-Eagle greens turf and reopen the course by October 1, 2022. The golf course closure and associated work resulted in a time in which the golf pro had no opportunity to generate revenue from the facilities but continued to have financial responsibility for many aspects of the operation. Substantiated and validated expenses of approximately \$230,061.00 were incurred by IAMJ Enterprises, Inc., against which he had no opportunity to generate revenue. During the period the course was closed, expenses such as maintaining the telephone lines, liquor license, insurance, pest control, and golf shop security system continued. The costs for staff to close and re-open the pro shop and café and losses for merchandise liquidation were also considered for compensation. Fixed costs will be paid monthly after receipt of documentation (e.g., invoices) evidencing his expenditures.

The City, through PKR, proposes to compensate IAMJ Enterprises, Inc., for professional services compensation in an amount not to exceed \$517,292.00 for concessionaire closure relief as a result of loss of revenue during closure of the golf course and to account for the time it will take to regenerate the customer base of Cedar Crest Golf Course. This closure impacted the public's perception of the golf course. By allocating funds to, IAMJ Enterprises, Inc., for his professional oversight during construction, he will have the opportunity to create new golf programs, invest in staff, rebuild the customer base, and create additional opportunities to generate interest in Cedar Crest Golf Course. Mr. Molayo, IAMJ Enterprises, Inc., will provide professional services by preparing the marketing plan for the course re-opening focused on community engagement, provide professional input during the grow-in by monitoring the greens, and complete other tasks during the shutdown.

During the term of the renovation and three months after reopening of the course, the City will assume all utility costs for the golf course, pro shop, and cart barn in an amount not to exceed \$7,538.00.

The proposed professional compensation is based on other municipal contract models used during similar golf course closures

This contract amendment will amend the golf professional concession contract with Ira Molayo, IAMJ Enterprises, Inc., previously approved by Council on June 11, 2008, by Resolution No. 08-1654.

On June 11, 2008, City Council authorized five concession contracts for one hundred twenty-six months, or ten and one-half years, each, with one sixty-month extension option each for Golf Pro Shop Management with Bob Smith at Tenison Park Golf Courses, Mickey Ray Piersall at L. B. Houston Golf Course, IAMJ Enterprises, Inc. at Cedar Crest Golf Course, and Tony Martinez at Grover C. Keeton Park Golf Course by Resolution No. 08-1654.

On June 11, 2008, the Park and Recreation Board authorized five concession contracts for one hundred twenty-six months, or ten and one-half years, each, with one sixty-month extension option each for Golf Pro Shop Management with Bob Smith at Tenison Park Golf Courses, Mickey Ray Piersall at L. B. Houston Golf Course, IAMJ Enterprises, Inc. at Cedar Crest Golf Course, and Tony Martinez at Grover C. Keeton Park Golf Course.

On September 14, 2012 ,by way of Administrative Action No. 12-2445, the parties entered into a supplemental agreement to clarify that the Concessionaire is responsible for the collection and payment of all sales and use taxes associated with the greens fees and all other services and goods provided under the contract.

On March 10, 2016, the Park and Recreation Board authorized the closing of Cedar Crest Golf Course to make improvements and renovations and provided concessionaire's expenses during such closing for a period beginning May 1, 2016 and ending on or about September 30, 2016.

On April 13, 2016, City Council authorized the closing of Cedar Crest Golf Course to make improvements and renovations and provided Concessionaire's expenses during such closing for a period beginning May 1, 2016 and ending on or about September 30, 2016 by Resolution No, 16-1542.

On September 20, 2018, the Park and Recreation Board authorized the sixty (60) month extension option at Cedar Crest Golf Course for Golf Pro Shop Manager Ira Molayo, IAMJ Enterprises, INC.

On January 28, 2019, City Council authorized the sixty (60) month extension option at Cedar Crest Golf Course for Golf Pro Shop Manager, IAMJ Enterprises, Inc., by Resolution No. 18-1827.

SUBJECT

Authorize an application for the North American Wetlands Conservation Act (NAWCA) Fund - Small Grant program in the amount of \$100,000 from the U.S. Fish and Wildlife Service for the Hines Park Wetlands Project, located at 9601 Harry Hines Boulevard - Financing: no cost consideration to the City.

BACKGROUND

The U.S. Fish and Wildlife Service administers the NAWCA Small Grant. Funding for this program supports public-private partnerships carrying out projects in the United States that further the goals of the North American Wetlands Conservation Act. These projects must involve long-term protection, restoration, and/or enhancement of wetlands and associated uplands habitats for the benefit of all wetlands-associated migratory birds. It is a competitive, matching grants program.

Hines Park is a 13.6-acre Conservancy Park, that was established in 2000 in Northwest Dallas. Hines Park is identified by the Dallas Park and Recreation Department as the candidate for this funding application due to its unique wetland that has developed, naturally over the last two decades, and supports over 28 species of birds, four species of waterfowl, three species of amphibians, and 102 species of native plants as identified through i-Naturalist and BioBlitz events recently held at the park.

The Dallas Park and Recreation Department intends to restore and enhance conditions at Hines Park that will help maintain the natural features of this critical wetland pond located within the park boundaries. The department's restoration activities will include removal of the nutria that have damaged existing waterflow, the addition of an inlet water pipe, and planting of native shoreline flora for erosion control.
