Executive Summary

Objective and Scope

The audit objective was to determine if internal controls are in place to ensure infrastructure designs conform with City Code Section 51A-8.601(b), *General Standards*. The scope of this audit included approved infrastructure design plans from January 1, 2023, through December 31, 2023.

Observed Conditions

The Planning and Development Department preserves evidence of the reviewed projects' conformance with the City Code in project comments and in inter-departmental emails but does not have a concise record showing each infrastructure design and construction project was reviewed specifically for conformance with each of the thirteen documents listed in City Code Section 51A-8.601 (b), General Standards even if some of them are not applicable. In addition, it is not clear if the list of the thirteen documents in City Code Section 51A-8.601(b) is complete, up-to-date, adequate, and applicable to the reviews done by Planning and Development. There is no single location for the thirteen documents where the public, developers, and professional engineers can locate and review the listed standards and requirements.

Recommendations

- Implement a written one-page checklist to document conformance with the thirteen documents listed in City Code Section 51A-8.601(b), General Standards.
- Update the requirements listed in City Code Section 51A-8.601(b), *General Standards* and communicate to the public and developers.

Background

City Code Section 51A-8.601 (b), *General Standards* states that all street paving, storm drainage, bridge, and culvert design and construction submitted by developers for review by the City of Dallas Planning and Development Department must conform to a list of thirteen specific documents (see Exhibit 1).

The Planning and Development Department uses a web-based database (ProjectDox) to review and track projects submitted by developers.

Objectives and Conclusions

1. Are there internal controls in place to ensure that infrastructure design and construction projects conform with City Code Section 51A-8.601(b), *General Standards*?

Generally, yes. Interviews with the Planning and Development Department's management and a review of a sample of projects in the department's electronic database, ProjectDox, showed that while the department does preserve evidence of the projects' conformance with the City Code in project comments and in inter-departmental emails, there is not a concise record showing each infrastructure design and construction project was reviewed specifically for conformance with each of the thirteen documents listed in City Code Section 51A-8.601 (b), *General Standards* even if some of them are not applicable. (See Observation A).

In addition, it is not clear if the list of thirteen items is complete, up-to-date, adequate, and applicable to reviews done by the Planning and Development Department. There is no single location for the thirteen documents where the public, developers, and professional engineers can locate and review the standards and requirements they are asked to conform with. (See Observation B).

Audit Results

Both *City Council Resolution 88-3428* and Administrative Directive 4-09, *Internal Control* prescribe policy for the City to establish and maintain an internal control system. The audit observations listed are offered to assist management in fulfilling their internal control responsibilities.

Observation A: Documentation of Compliance with City Code Section 51A-8.601 (b)

City Code Section 51A.8-601 (b), *General Standards* states that all infrastructure design and construction projects submitted by developers for review by the City of Dallas Planning and Development Department must conform to the standards, criteria, and requirements listed in the thirteen documents referenced in Exhibit 1 on page one of this report.

The Planning and Development Department's engineers review the designs' conformance with City Code, ask for corrections, refer the designs for review to other city departments (for example, to Dallas Water Utilities for drainage related reviews), and ultimately approve or reject the submitted designs. In practice, not all infrastructure design and construction projects involve elements from each of the thirteen documents listed in Exhibit 1. For example, infrastructure design and construction projects that are not located in the Central Business District do not have to conform to the Central Business District Pedestrian Facilities Plan. Therefore, the Planning and Development Department's review of infrastructure design and construction projects is guided by current infrastructure design and construction code and staff's professional experience.

Interviews with the Planning and Development Department's management and a review of a sample of projects in the department's electronic database, ProjectDox, showed that while the department does preserve evidence of the projects' conformance with the City Code in project comments and in inter-departmental emails, there is not a concise record showing each infrastructure design and construction project was reviewed specifically for conformance with each of the thirteen documents listed in City Code Section 51A-8.601 (b), *General Standards* even if some of them are not applicable.

As a result, to demonstrate that each infrastructure design and construction project was reviewed for conformance with each of the thirteen documents listed City Code Section 51A-8.601 (b) even if some of them are not applicable, the Planning and Development Department has to review numerous project notes and inter-departmental emails.

Criteria

- City Code Section 51A-8.601 (b), General Standards
- Standards for Internal Control in the Federal Government, *Principle 10 Design Control* Activities

We recommend the **Director of Planning and Development Department:**

A.1: Implement a written one-page checklist and use it to document that each infrastructure design and construction project submitted by developers has been reviewed for conformance with each of the thirteen documents listed in City Code Section 51A-8.601 (b), *General Standards*.

Observation B: The Origin of City Code Section 51A-8.601 (b)

The origin of the City Code Section 51A-8.601 (b), *General Standards* list of documents and the purpose of the list is not clear. It is also not clear if the list of thirteen items is complete, up-to-date, adequate, and applicable to reviews done by the Planning and Development Department.

There is no single location for the thirteen documents where the public, developers and professional engineers can locate and review the standards and requirements they are asked to conform with. The Planning and Development Department's personnel were unable to locate some of the items mentioned in City Code Section 51A-8.601 (b), *General Standards*. In addition, the list includes several vaguely titled items that the Planning and Development Department's staff were unable to identify at all. (See Exhibit 2 below).

Ambiguous Items in Section 51A-8.601 (b)

As a result, the Planning and Development Department is unable to ensure that each infrastructure design and construction project reviewed by the department conforms to the latest standards, criteria, and requirements applicable to each submitted construction design project. The department has not reviewed or updated the requirements listed in City Code Section 51A-8.601 and has not communicated these requirements to the public and developers.

Criteria

We recommend the **Director of Planning and Development Department:**

B.1: Review and update the requirements listed in City Code Section 51A.8-601 (b), *General Standards*.

B.2: Communicate to the public and developers the list of the requirements they are asked to conform with, their applicability, location, and how to access the location of the requirements.

B.3: Implement a written procedure with work instructions on how to periodically review and update the requirements listed in City Code Section 51A.8-601 (b), *General Standards*, and update their applicability, location, and how to access the location of the requirements.

Appendix A: Background and Methodology

Background

The Planning and Development Department reviews commercial and residential development and redevelopment projects, issues construction and trade permits, and processes Certificates of Occupancy applications for new and existing businesses. During the audit period from January 1, 2023, to December 31, 2023, the department performed 11,318 of Commercial and Residential Plan Reviews.

The department's fiscal year 2024 budget is \$53,952,347, a decrease from Fiscal Year 2023 budget of \$54,659,486. The regular Full-Time Equivalent (FTE) budget in Fiscal Year 2024 is 344.72, which is an increase from fiscal year 2023 when the Full-Time Equivalent budget was 318.77.

The Planning and Development Department uses ProjectDox (a web-based database) to review plans submitted by developers and to document the results of the review.

Methodology

The audit methodology included: (1) interviewing personnel from the Planning and Development Department, Transportation and Public Works Department, and other city departments; (2) reviewing policies and procedures, the *Dallas City Code*, applicable Administrative Directives; and (3) reviewing a sample of infrastructure design and construction projects in the ProjectDox database. In addition, all five components of *Standards for Internal Control in the Federal Government* were considered.

We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based upon our audit objective. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objective.
