Discussion Items:

Each Board member introduced themselves and their district,

ECO- Office of Economic Development: Assistant Director Kevin Spath presented an overview of the goals, policies, services, and programs of the Office of Economic Development, a summary of previous bond programs and previous economic development/housing propositions, and the criteria by which prospective economic development projects are evaluated for possible bond

funding support. For next steps, Mr. Spath explained that the Office of Economic Development would not be recommending a field trip but would be providing a more detailed presentation at the next meeting on May 25.

Department of Housing and Neighborhood Revitalization:

Director Noguera discussed tour date options: Saturday June 10th 9am-2pm was decided as final date and time. A question was raised regarding the list for home repair applications, Director Noguera advised that HOU stopped maintaining a waiting list because the list rose to thousands, the list is refreshed every year. Director Noguera went over HOU Org chart and detailed the roles of each Assistant Director, he also discussed the division responsibilities, HOU's various programs, budget, performance, Dallas Housing Policy 2033, Dallas Housing Resource Catalog, the alignment of DHP33 & DHRC, integration, HOU's 7 pillars. The 7 pillars are as follows:

- 1. Equity Strategy and Target Areas
- 2. Citywide Production
- 3. Citywide Preservation
- 4. Infrastructure
- 5. Collaboration and Coordination
- 6. Engagement
- 7. Education

Office of Homeless Solutions:

Director Crossley from OHS discussed the four-track strategy, which is their departments guiding principles, when they spend money, it must be tied to the four-track strategy:

- 1. Track 1- Increase shelter capacity,
- 2. Track 2- Inclement weather shelters,
- 3. Track 3—Subsidized supportive housing, and
- 4. Track 4- Investments in facilities combatting homelessness.
