

NOTICE OF PUBLIC REVIEW AND COMMENT PERIOD FOR THE CITY OF DALLAS FY 2019-20 HUD ACTION PLAN

The purpose of this notice is to inform residents of the proposed temporary program expansion of the Out of School Time Program to prevent, prepare for, and respond to the COVID-19 pandemic. The Out of School Time Program is operated by the City of Dallas Park and Recreation Department and funded by Community Development Block Grant funds received from the US Department of Housing and Urban Development. The program currently operates at three recreation centers and 24 Dallas ISD schools to provide after-school and summer activities for low and moderate-income youth (ages 6-12), Monday through Friday. The expanded program will host supervised virtual learning centers at 34 recreation centers during the time frame in which Dallas ISD is conducting only virtual classroom settings. Virtual centers are needed due to low internet connectivity rates in households throughout the city of Dallas, particularly in the southeast, south, southwest and west sectors of Dallas. The program will operate Monday through Friday from 7:30am-3:30pm until Dallas ISD opens for in-person learning. Once in-person learning resumes, the supervised virtual learning centers will halt, and Park and Recreation will begin in-person afterschool programs at the designated DISD campuses. The temporary program will serve 350 youth.
