# **REAL ESTATE ABANDONMENTS**



**WHO SHOULD USE THIS BROCHURE**: A property owner whose property abuts a public right-of-way applying to the City for the purchase or "abandonment" of the right-of-way. Fees charged in accordance with the Dallas City Code.

PRIOR TO APPLYING FOR ABANDONMENT, PLEASE SUBMIT ENGINEERING PLANS TO PDV ENGINEERING, 320 E. JEFFERSON BLVD., ROOM 200 OR engadmin@dallas.gov. OBTAIN WRITTEN AUTHORIZATION FROM PDV-ENGINEERING [(WATER/WASTEWATER) AND (PAVING AND DRAINAGE)] TO PROCEED WITH ABANDONMENT REQUEST.

## **Typical Steps (Minimum of 3 Months):**

(1)	•REQUEST THE ABANDONMENT
(2)	•ROUTE FOR DEPARTMENT/UTILITY COMMENTS
(3)	•REQUEST APPRAISAL, IF APPLICABLE
(4)	•SUBMIT DRAFT ORDINANCE FOR REVIEW
(5)	•COUNCIL CONSIDERS FOR APPROVAL
(6)	•QUITCLAIM / CERTIFIED ORDINANCE FILED OF RECORD

### **To Begin Process:**

- ☐ Submit request Letter from Applicant
  - Proposed use and intended purpose
  - Number of jobs created by project
  - Start and end date of project
  - Name, address and email of representative, if applicable
- ☐ Submit Fees

- ☐ Three (3) sets of Survey Field Notes with SPRG Checklist+
- ☐ Ownership Deed for Applicant's Property abutting proposed Abandonment Area
- ☐ Dedicatory Instrument (How proposed Abandonment Area was Dedicated to City)
- ☐ Letter of Consent from Non-Participating Abutting Owners, if applicable+
- ☐ Proposed Design, Conceptual Plan, Site Plan For Anticipated Project
- ☐ Additional Documents, as warranted

## **Abandonment Processing Fee**

Minimum \$11,150.00 or Appraised Value, whichever is greater

Utility Easement(s)
(Dedicated at no cost to City)

\$11,150.00 plus \$1,000.00

for each easement in excess of five (5)

Ordinance Publication Fee

\$20.00

(Abandonment/Processing fee payable to *City of Dallas* by wire or cashier's check)

#### **Prior to Council:**

Before an Abandonment can be considered by Council, you must also:

- Execute and provide Form 1295, if applicable
- Execute Acceptance Letter
- Execute a No Conflict-of-Interest Statement
- Pay Abandonment Processing fee and any additional recording fees
- Resolve unpaid taxes and code violations
