Minimum Requirements for Promotion

CODE OF RULES AND REGULATIONS OF THE CIVIL SERVICE BOARD -

Battalion-Section Chief: Those employees who have served in the Fire Department for seven years and who have served as Fire Captain for eighteen months shall be eligible for promotion to this rank. (Civil Service Rule XIV, Section 1. B. (1) (m))

Those candidates who will meet the eligibility criteria by February 14, 2020 may compete on this examination but will not be eligible for promotion until they have successfully completed service required for promotion. (Civil Service Rule XIV, Section 1. B. (2) (a))

Application to take the Written Exam

All persons wishing to take this examination must submit a promotional application. The application can be found on the City of Dallas Internal Positions Employment Opportunities webpage at:

Applications will be accepted from Wednesday, May 15, 2019 to Friday, June 14, 2019. You must register no later than 11:59 p.m. on Friday, June 14, 2019 or you will not be allowed to take this examination.

When you have signed up successfully for the test on the NEOGOV system, you will receive an automated email confirmation from NEOGOV (to the email address you designate on your application). In addition, you will receive an email notification from the Civil Service Department with your eligibility status on July 1, 2019.

Fire Battalion Chief Promotional Process - Part I

This promotional process consists of two parts. Part I consists of a multiple-choice knowledge examination and will cover relevant knowledge areas from the source list attached (Appendix A).

Candidates must pass the written examination (Part I) to compete in the assessment center (Part II). The passing score for Part I of the examination will be set as described in the WRITTEN EXAMINATION PROCEDURES. The WRITTEN EXAMINATION PROCEDURES will be sent to you on July 1, 2019. <u>Failure to follow these procedures may disqualify you from taking the written exam</u>. The results of Part I of the examination will be combined with the results of Part II to determine the final score for those individuals completing both parts.

The multiple-choice examination will contribute <u>39 %</u> and the assessment center will contribute <u>61 %</u> to a candidate's overall promotional score. These weights were determined by the job analysis for the position conducted in 2016.

Fire Battalion Chief Promotional Process - Part II

Part II consists of an Assessment Center containing three exercises.

Those candidates passing Part I of the promotional process will have the opportunity to attend an Assessment Center orientation. These orientation sessions will be held Monday, September 9 and Tuesday, September 10, 2019. Additional information will be provided in Announcement II which will be distributed on August 14, 2019 at the written examination site.

Part II of the examination is scheduled for administration on **Wednesday - Friday, October 9 - 11, 2019**. Details of the schedule will be provided to individuals eligible to compete in this part of the examination.

In accordance with the policy of the Civil Service Board, assessment center test exercises will NOT be subject to review. Feedback will be provided to individuals on all assessment center exercises they complete.

ADA Accommodation Requests

Any candidate who requires an accommodation for Part I or Part II of this examination, in accordance with the Americans with Disabilities Act (ADA) must make this request for accommodation in writing to the Civil Service Department. ADA accommodation requests for Part I must be received by Monday, July 15, 2019. ADA accommodation requests for Part II must be received by Friday, September 13, 2019.
