**Manager of Pool Operation Class Schedule 2019**

Dear Pool and Spa Owners:

Chapter 43A of the Dallas City Code requires a 'Manager of Operations' certification for a pool/spa. Certificates are renewable every two (2) years. The certification classes are conducted by the Department of Code Compliance.

To register for a class, the enclosed **Manager of Pool Operations-Class Registration Form** must be completed and ***submitted*** to the Department of Code Compliance. Please make sure that you list a class preference date on the form. A registration form must be completed for each person attending the class. You may copy the form if needed. Maximum class size is 30.

Registration is \$47.00 per person for City of Dallas residents; and \$47.00 per person for non-residents. Submit your class registration form along with your check or money order, made payable to the City of Dallas. Payment must be made in person or mailed to **Special Collections Division** at 1500 Marilla St., Suite 2DS, Dallas, Texas 75201. Payment will not be accepted at class. Registration payments are **non-refundable**. ***To cancel or substitute a class, Code Compliance staff must be notified by phone at (214) 671-2791 at least 48 hours prior to class date. Failure to do so will result in payment forfeiture.***

**Class instruction will be in Spanish on designated dates.**

**All students are required to bring a DPD pool test kit, calculator, and a pencil/pen.**

**Class will begin at 9:00 a.m. – 1:00 p.m.**
