## Area in Dallas to be sprayed for Mosquito Abundance

**Dallas** – The City of Dallas will be spraying for mosquito abundance in the areas listed below. Weather permitting the areas delineated below is scheduled for mosquito control spraying on Tuesday, May 30, 2017 and Wednesday, May 31, 2017 between 9 p.m. and 5 a.m. each night.

**Control Area:** The area to be sprayed is within an area generally bounded by: 3700 block of Bickers Street (75212): **BAYSIDE STREET** on the north, **NORWICH STREET** on the west, **FUREY STREET** on the east, and **NOMAS STREET** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 4700 block of Thedford Avenue (75209): **WATEKA DRIVE** on the north, **WEBSTER STREET** on the west, **ORIOLE DRIVE** on the east, and **WEST MOCKINGBIRD LANE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 2800 block of Scottsbluff Drive (75228): **MAVERICK AVENUE** on the north, **ASHDOWN DRIVE** on the west, **MICHAEL LANE** on the east, and **BLYTH DRIVE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 6200 block of Oram Street (75214): **BELMONT AVENUE** on the north, **MODERN PLACE** on the west, **ABRAMS ROAD** on the east, and **LIPSCOMB AVENUE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 7200 block of Vivian Avenue (75223): **LA VISTA DRIVE** on the north, **LINDSLEY AVENUE** on the west, **EAST GRAND AVENUE** on the east, and **CLERMONT AVENUE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 10700 block of Sandalwood Drive (75228): **CASSANDRA WAY** on the north, **SHILOH ROAD** on the west, **SANDRA LYNN DRIVE** on the east, and **GUS THOMASSON ROAD** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 11900 block of Woodbridge Drive (75243): **LARCHGATE DRIVE** on the north, **AUDELIA ROAD** on the west, **GARDEN TERRACE DRIVE** on the east and, **FOREST LANE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 10100 block of Church Road (75238): **FAIRCREST DRIVE** on the north, **CLEARMEADOW DRIVE** on the west, **TRAILPINE DRIVE** on the east, and **ESTATE LANE** on the south.

**Control Area:** The area to be sprayed is within an area generally bounded by: 6000 block of Lakehurst Avenue (75230): **WAGGONER DRIVE** on the north, **LAKEWAY COURT** on the west, **TULANE BOULEVARD** on the east and **WALNUT HILL LANE** on the south.

While the insecticide is approved by the Environmental Protection Agency for treatment, residents in the above areas should avoid contact with the spray by staying indoors. Persons inside a vehicle while trucks are actively spraying should remain in their vehicles with the windows up and the air conditioner on until the trucks pass and the spray is no longer visible. Persons out during the scheduled spraying time should be alert for trucks and should not follow them. Residents who come in contact with the spray are advised to wash the affected area thoroughly with soap and water. The spray breaks down quickly in the presence of sunlight and has no residual effect.

### **Protection against mosquito bites**

Dallas residents are urged to take precautions against mosquito bites by reducing outdoor activity during evening and nighttime hours. Residents who are outside during these times should cover their arms and legs and use a mosquito repellent.

### **Prevent mosquito breeding**

Residents should eliminate standing water to prevent mosquito breeding and the spread of West Nile Virus. Breeding places for mosquitoes include swimming pools that are not kept clean, stagnant ponds, pet watering dishes, birdbaths, potted plants, old tires, empty containers, toys and clogged rain gutters and French drains. Standing water should be eliminated promptly, as mosquitoes can grow from egg to adult in as little as seven days.
