**WHEREAS**, the 89th Session of the Texas Legislature will convene in January 2025; and

**WHEREAS**, many legislative issues affecting local government will be considered; and

**WHEREAS**, the City of Dallas has historically adopted a legislative program for consideration by the Legislature; and

**WHEREAS**, the Ad Hoc Committee on Legislative Affairs was briefed on December 11, 2023; and

**WHEREAS**, the Ad Hoc Committee on Legislative Affairs was briefed on May 28, 2024.

**WHEREAS**, the Ad Hoc Committee on Legislative Affairs was briefed on August 27, 2024.

**WHEREAS**, the City Council was briefed on September 18, 2024.

**WHEREAS**, the City Council moved the state legislative program forward on October 8, 2024.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City of Dallas Legislative Program for the 89th Session of the Texas Legislature is hereby adopted.

**SECTION 2.** That the state legislative program for pensions will be overseen by the Ad Hoc Committee on Pensions.

**SECTION 3.** That the City Attorney is directed to communicate the items included in the state legislative program to members of the Texas Legislature.

**SECTION 4.** That the City Attorney is directed to support legislation that upholds the City of Dallas' home-rule authority, as well as oppose legislation that diminishes resources or home-rule authority.

**SECTION 5.** That except as provided in Section 6, for those issues that arise during or prior to the Session for which there is no official City position and there is insufficient time to convene a meeting of the Ad Hoc Committee on Legislative Affairs or the City Council, the Chair of the Ad Hoc Committee on Legislative Affairs is authorized to represent and protect the interests of the City.

**SECTION 6.** That for pension issues that arise during or prior to the Session for which there is no official City position and there is insufficient time to convene a meeting of the Ad Hoc Committee on Pensions or the City Council, the Chair of the Ad Hoc Committee on Pensions is authorized to represent and protect the interests of the City.

**SECTION 7.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.





### **PURSUE (draft legislation, secure an author, get passed)**

1. Maintain local control.
2. Codify the city's funding plan for the Dallas Police & Fire Pension System.
3. Define the use for Less Lethal Devices in the Texas Penal Code to ensure law enforcement agencies may use innovative life-saving technologies.
4. Enhance residential and commercial protections against squatting.
5. Pursue legislation to capture a portion of the short-term car rental tax for parks and trails improvements.
6. Pursue legislation to make accessible harm reduction strategies to combat the opioid epidemic.
7. Pursue legislation aimed at mitigating theft of communications facilities of copper, fiber, and other necessary equipment needed to ensure customer access to vital emergency communications services.
8. Amend local government election dates and authorize ranked choice voting for local government elections.

### **MONITOR**

1. Monitor funding and oversight relating to pensions.
2. Business opportunities to grow the tax base and ensure Dallas receives its fair share of revenue that may be generated from gambling, if authorized by state law.
3. Enhance safety for residents of senior facilities.
4. Access to a vibrant and diverse collection of materials and resources in Dallas public libraries that represent the interests and needs of all residents of Dallas. Workforce, Education, and Equity.
5. Protect whistleblowers and maintain ethical standards and accountability in the workplace.
6. Establish the Department of Public Safety as the primary first responder on state highways.
7. Expand Baby Moses Law age.
8. Authorize local law enforcement agencies to conduct driving while intoxicated checkpoints to combat the prevalence of drunk driving, motor vehicle accidents, and fatalities.
9. Amend the Public Information Act to exempt preliminary recommendations derived from early warning software platforms designed to support proactive employee intervention.
10. Amend statute to include a ten-year minimum sentence for aggravated assault on a peace officer.

### MONITOR

11. Adopt a statewide minimum cash bail schedule for eligible violent felonies and mandate the revocation of bail of defendants arrested for any violent felony while the defendant is awaiting trial on a previously charged violent felony.
12. Mandate that judges order participation from high-risk violent offenders in focused deterrence programs as a condition of probation or parole.
13. Protect privacy and security of resident and commercial data.
14. Require mandatory disclosure of residential and commercial real estate sales prices.
15. Ensure project delivery processes serving residents and industry are effective and transparent.
16. Establish a database of homestead exemptions.
17. Expand options for publication of legal notices.
18. Clarify the local government procurement process to include price consideration of purchasing goods.
19. Legalize marijuana and seek additional research metrics regarding its economic, health and safety effects.







SUBJECT Recusal – Dallas Police/Fire Pension Fund Lawsuit and Legislative Efforts

This memo serves as my intent to recuse myself from discussions and decisions surrounding the Dallas Police Fire Pension Fund lawsuit and legislative efforts for the passage of any bill associated with the Dallas Police and Fire Pension. I have previously received a legal opinion from the City Attorney that I had no conflict of interest associated with the Dallas Police Fire Pension and the fact that the Chief Legal Counsel for the pension fund is my brother. Out of an abundance of caution and transparency, I have not participated in discussions regarding the lawsuit.

I recently asked for an updated opinion from the City Attorney, and it affirmed I do not have any conflict, but it raised the possibility that a perceived conflict of interest should be considered. Given the opinion, I have decided to officially recuse myself and remove even the possibility of a perceived conflict by continuing to not participate in the lawsuit discussions and additionally, not participate in the legislative process associated with the pension fund.
