**REDISTRICTING COMMISSION  
PUBLIC HEARINGS  
RULES OF COURTESY FOR SPEAKERS**

**The Redistricting Commission is anxious to hear from as many Dallas residents as possible to learn about concerns and issues with the existing City Council districts and with any proposed draft plans put forward by speakers as potential methods of redrawing the districts. In order to make this hearing process work as smoothly as possible, the Commission has adopted the following rules of courtesy:**

1. All persons wishing to speak must sign up at check-in with the Redistricting Staff and provide the requested sign-in information.
2. If a speaker has spoken at a previous Public Hearing of the Commission, the person will be placed on the speaker list after those wishing to speak who have not spoken previously. Priority will be given to speakers living in the districts hosting the public hearing.
3. Speakers will be given a number by the staff when they sign up. They will be called up to speak by the Chair by the number assigned, and it is requested that to expedite the process that the speakers move into position to speak when their number is close to being called.
4. Each speaker shall have a maximum of 3 minutes with the time limit to be determined the night of the meeting, depending on the number of speakers that are signed up to speak. The speaker will be signaled when there is 30 seconds left and must close his/her comments within the time period. Members of the Commission will not interrupt the speaker with questions, but may ask questions of the speaker at the end of the speaker's comments.
5. Each speaker must keep his/her comments or questions to redistricting or will be ruled out of order by the Chair.
6. Speakers shall observe the same rules of propriety, decorum and good conduct applicable to members of the Commission. Any speaker making personal, impertinent, profane, or slanderous remarks or who becomes boisterous while addressing the Commission will be removed from the room.
