## REVIEW CRITERIA

**1. Population Equality:** All districts should have substantially equal population.

This plan submission meets the population equality test. All districts have less than a 5.6% percent deviation from the optimal district size, with an average deviation of **2.70%**. The total range of deviation is **9.84%**.

**2. Minority Representation:** Voting strength of minorities should not be diluted.

This plan submission meets the minority representation test. This plan includes 7 minority districts and 2 minority coalition districts. No retrogression of minority representation from the 2001 District Plan is noted.

Packing is noted in the total and voting age Hispanic population in District 1.

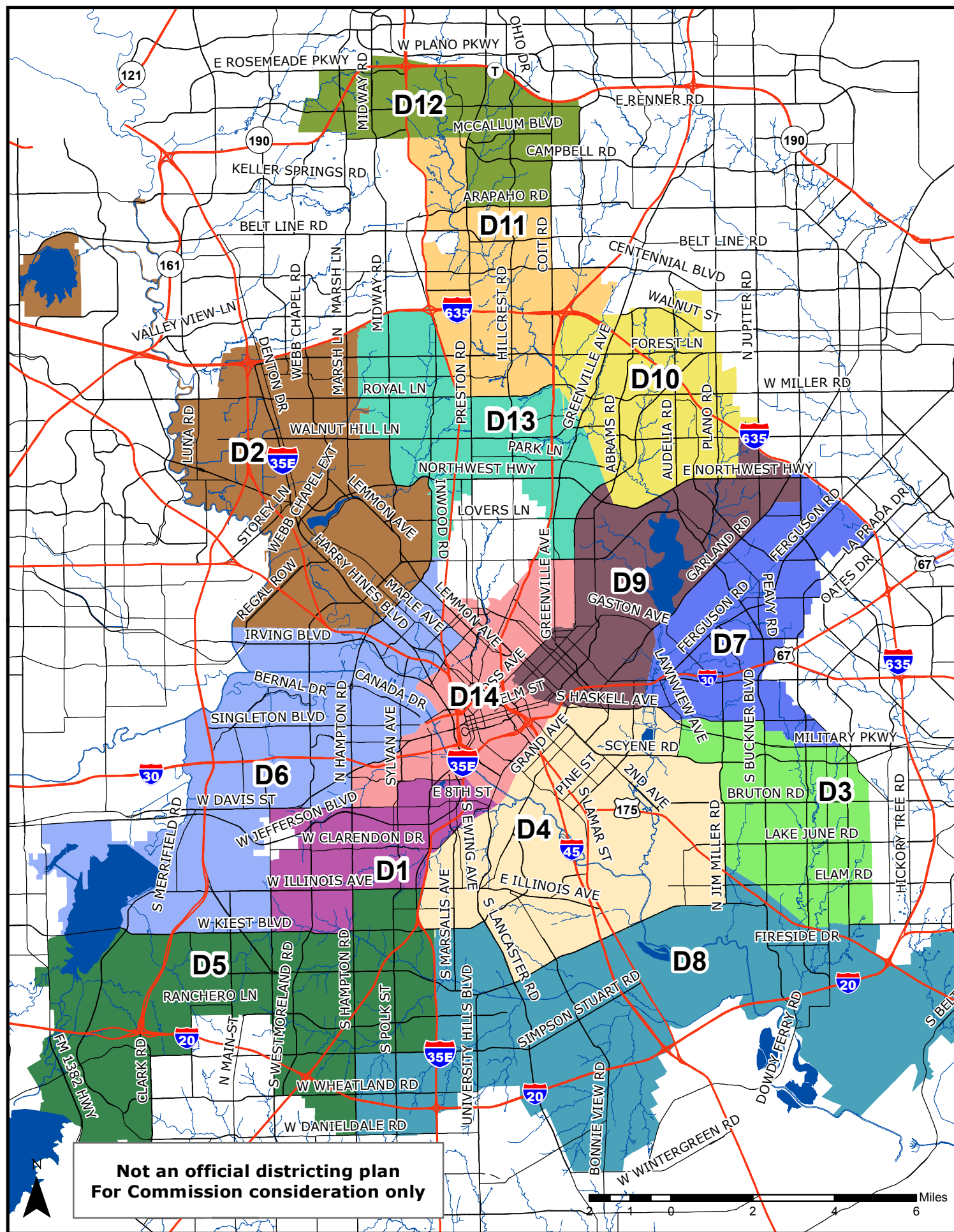
