Madam Chair Morgan & Members:

14-1 was by far the greatest political win for minorities in the City of Dallas, more so than even electing the first Black Mayor Ron Kirk. However, we must always remember that 14-1 was not created for just one race or one group, but for equal representation of *all* ethnic and social groups.

As our beautiful city continues to grow, so will our demographics. In my opinion it's exciting to see our city change in unprecedented ways. As the demographics change within our communities, so will the need for change of boundaries for those representatives. Thus we have redistricting. However, redistricting should not be used as a tool to protect incumbent's vs. protecting public interests. Redistricting should not be used to divide geographic areas, but to unify neighborhoods. The citizens of Dallas have entrusted our representatives our leaders, to put our interests first and thus, they have placed part of that responsibility on you for this task and we hold you to that same level of accountability.

The map that I propose is called the Bryant123 Map. I have addressed three (3) main issues with the current 2003 map and its relationship to the current 2010 census data.

1) Pleasant Grove

It has been stated that in Pleasant Grove alone there are over 100,000 residents. That area just as Oak Cliff, is divided among three (3) Council representatives. Unlike Oak Cliff, however, for Pleasant Grove none of those three (3) representatives live in Pleasant Grove. Being a resident of Oak Cliff, I feel their compassion and their need for **their own representation**.

2) West Dallas

In the year of 2011, our city should be about unifying and not dividing. Just as Pleasant Grove is divided among three (3) districts, West Dallas is divided into two (2) districts.

3) New Minority Opportunities in North Dallas

As the Bryant123 Map creates a new Hispanic Pleasant Grove District it will thus loose an African-American District. I propose to make that District up in the current District 10 in North Dallas.

The 2010 Census Data concludes that 42% of the City of Dallas residents are Hispanic, 29% are Anglo and 25% are African-American. In all, the Bryant123 map will benefit the entire City of Dallas and allow us to become that "World Class City" that we all claim to strive for.

How does this map follow the Redistricting Guidelines?

Population Equality

In the Bryant123 Map, out of 14 Council Districts the margin from the least populated District to the highest populated District is 7,478, it complies with the Voting Rights Act by encompassing 7 minority districts and 2 minority coalition districts and not only maintains neighborhoods but unifies geographical areas and preserves existing core districts.

Minority Representation

In the Bryant123 Map, the 2010 Census data is well distributed by having a possible 5 Hispanic Districts (42% of population), 5 Anglo Districts (29% of population) and 4 Black Districts (25% of population) based on District Demographics of Voting Age percentages.

Contiguity and Compact

By unifying areas such as West Dallas and Pleasant Grove the Bryant123 Map preserves the existence of common social, cultural, community and economic interests and definitely allows the ability for constituents to relate not only to each other but to their representative.
