Subject: Redistricting WPlan12

My proposed redistricting plan (wPlan16) complies with the Redistricting Guidelines as follows:

- 1. Population equality: No district varies more than .10 percent from the 85,558 number that represents one fourteenth of the city's population. The largest negative deviation is 78 (District 3), and the largest positive deviation is 70 (District 8).
- 2. Minority representation: Five districts (1, 2, 3, 5, 6) are majority Hispanic both in overall population and voting age population. One district (9) is majority Hispanic in overall population and majority white in voting age population. Three districts (4, 7, 8) are majority black both in overall population and voting age population. The remaining five districts (10, 11, 12, 13, 14) are majority white both in overall population and voting age population.
- 3. Contiguity and compactness: All districts are contiguous, while they are also more compact than the current configuration. For example, District 14 no longer stretches west of the Dallas North Tollway, and Districts 2, 4, 5 and 7 no longer snake radically across the city. Additionally, District 3 no longer includes the southwest corner of the city, which is now better represented by District 4. The plan also uses many natural boundaries, such as Interstate 35, Interstate 30 and the Trinity River.
- 4. Incumbents: The residences of incumbent council members or potential challengers was not a consideration in this remapping.
- 5. Communities of interest: As much as possible, communities were kept intact, while others were properly placed together. For example, Pleasant Grove, which once was included in four separate districts (2, 5, 7 and 8), is now one district (5).
