This plan submission meets the population equality test. All districts have less than a 0.01% percent deviation from the optimal district size, with an average deviation of **0.01%**. The total range of deviation is **0.03%**.

2. Minority Representation: Voting strength of minorities should not be diluted.

This plan submission meets the minority representation test. This plan includes 6 minority districts and 3 minority coalition districts. No retrogression of minority representation from the 2001 District Plan is noted.

Packing is noted in the Total Black Voting Age Population in District 4 (71.40%).

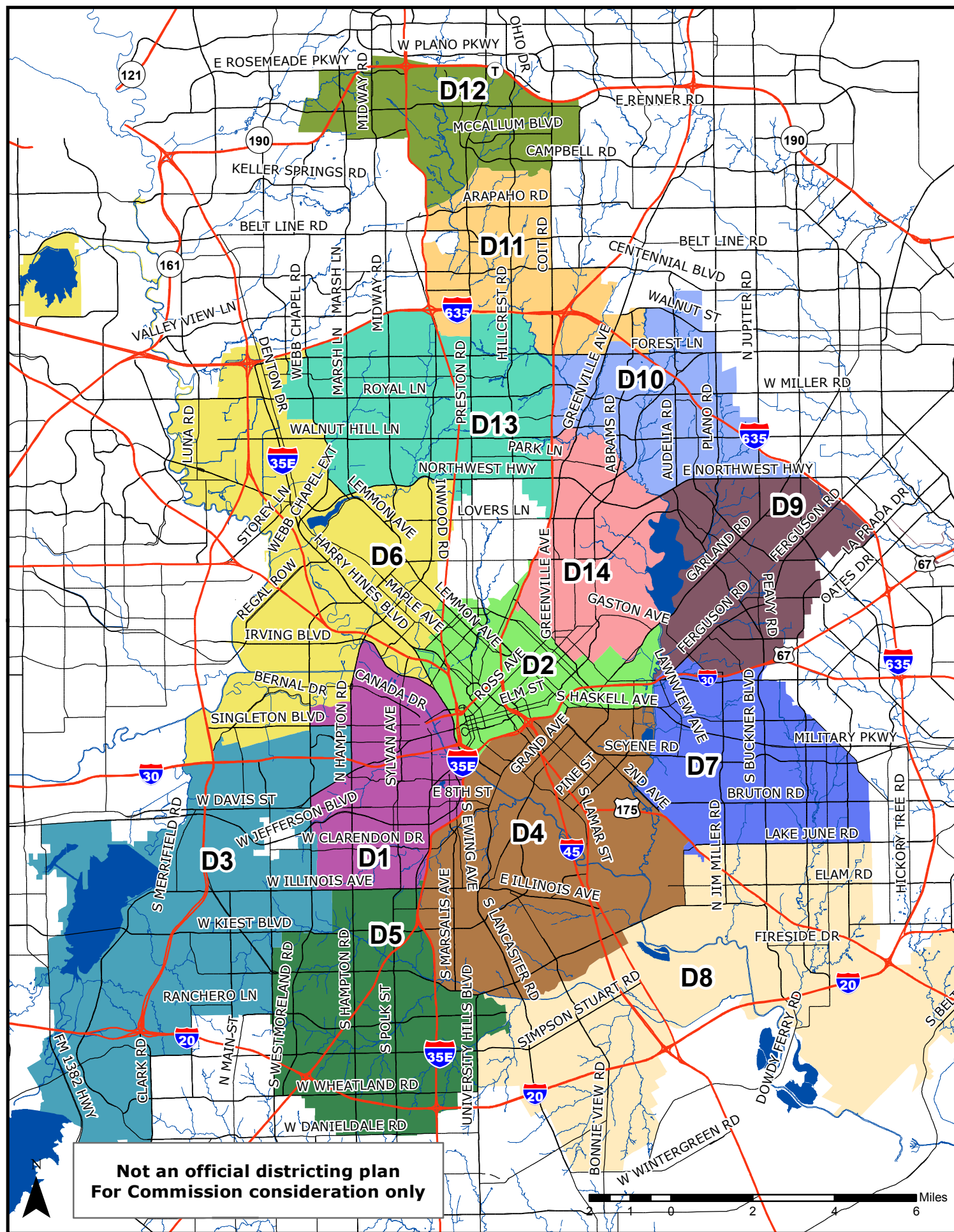
