## REVIEW CRITERIA

**1. Population Equality:** All districts should have substantially equal population.

This plan submission meets the population equality test. All districts have less than a 3.9% percent deviation from the optimal district size, with an average deviation of **1.33%**. The total range of deviation is **6.37%**.

**2. Minority Representation:** Voting strength of minorities should not be diluted.

This plan submission meets the minority representation test. This plan includes 8 minority districts and 1 minority coalition districts. No retrogression of minority representation from the 2001 District Plan is noted.

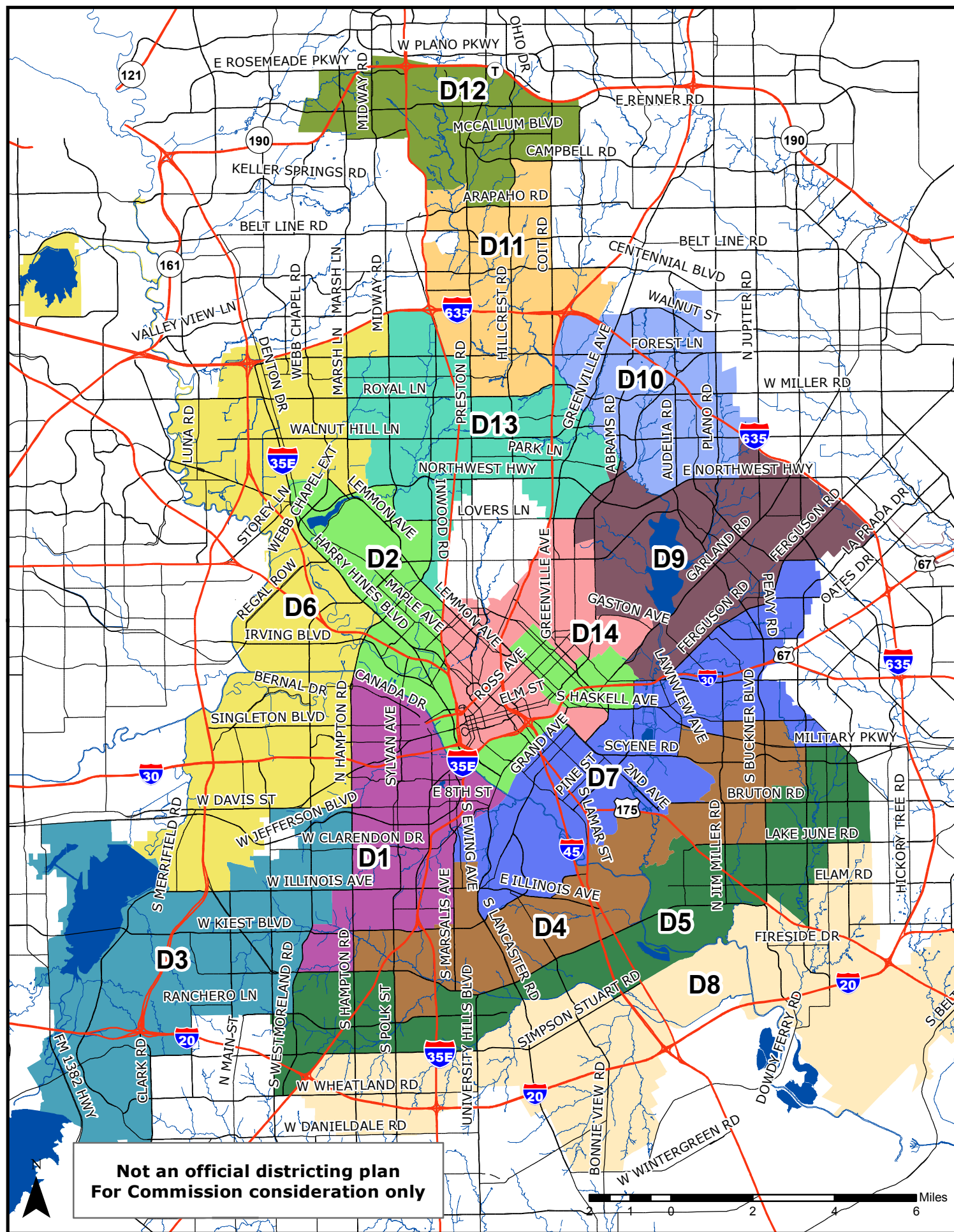

- District 6 is the largest district exceeding the target 3,256
- District 7 is the smallest, short of the target 2,187
- total deviation is 5,713, well within the legal requirement

**Minority Representation** - This map meets the standard for minority representation.

- (4) voting age majority Hispanic districts - 1, 2, 3, & 6
- (4) voting age majority Black districts - 4, 5, 7, & 8
- (5) voting age majority White districts - 9, 11, 12, 13, 14
- (1) minority coalition district - 10

This plan answers the call for 4 Black voting age majority districts with 52.30%, 51.93%, 51.51%, & 50.85%

This plan has 4 Hispanic voting age majority districts with 64.69%, 64.01%, 62.49%, and 57.07%

**Contiguity and Compactness** - All districts are contiguous and reasonably compact compared to previous district maps.

Districts 14 and 2 have become more compact by curving inward. Each now makes a single main curve as they receptively hug the entertainment districts and the working class minority neighborhoods surrounding downtown and love field. District 14 sees a new western boundary at the tollway instead of Love Field, and District 2s eastern bound is now at Tenison Parkway from White Rock Creek.

The least compact districts 8, 5, 6, 4, & 2 bear a strong resemblance to their historical shapes.

**Communities of Interest** - The majority of most districts remain intact and these maps serve to hold together communities of interest as much as can be met within the guidelines. The Social, cultural, and ethnic interests play a strong role in the shapes.
