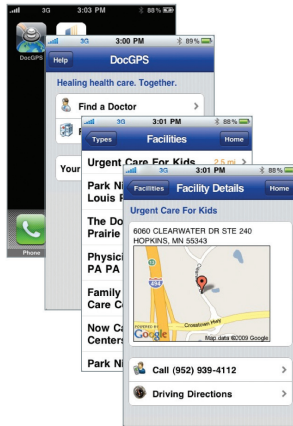


# Mobile Technology for People On the Go

**DocGPS** is an app that combines a search function with GPS mapping to help BlackBerry®, Android™ or iPhone® users find UnitedHealth Premium® designation program providers and local care.

- Locates nearby in-network doctors, clinics and hospitals by specific health plan
- Searches on 23 types of health care facilities and 58 types of physician specialties
- Uses global positioning system (GPS) to locate and map locations
- Auto dial feature
- DocGPS 2.0 is available as a free download on the iPhone, select BlackBerry devices (Curve™ 8900, Storm™ 9530 and Bold™ 9000) and smart phones powered by Google's Android operating system v1.5 and later

**myuhc.com mobile** gives members access to the most frequently requested information and tools on our member website.

- Provider search (GPS-enabled)
- Benefits summary
- Account balances
- Recent claims
- ID card view (with fax and e-mail functions)

- Voice recognition and navigation

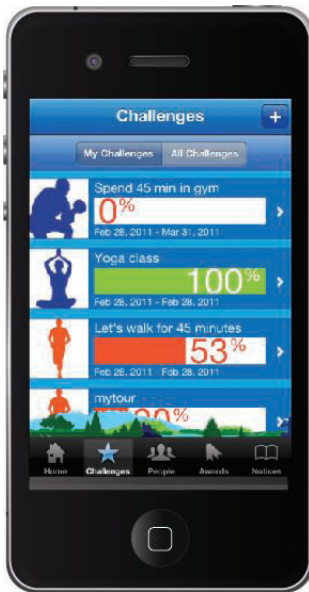
