By signing below, I am agreeing to participate in the City of Dallas' 2007 DART Annual Gold Pass Program, effective **December 1, 2006 through November 30, 2007**. I understand the Terms and Conditions of this program and know that in order for me to participate, I must be on the City of Dallas payroll and classified as either **Active Temporary, Permanent Part-Time, Permanent Full-Time, or Uniformed Dallas Fire and Rescue**. *(Sworn Dallas Police Officers do not qualify).*

Should I terminate employment with the City of Dallas due to discharge, resignation, reduction-in-force or any other reason, I agree to return the Annual Gold Pass to the Human Resources Department. I understand that failure to return the pass will result in a **fine of \$25.00 (Non-Refundable)** deducted from my final paycheck.
