I'm not going to read it all because it's a lot. 19 "Sarah May" (68274688) 00:05:15.839 --> 00:05:25.679 Of of it would take a while to get through, but essentially, um, it's regarding 3 uses childcare facility, adult daycare facility. 20 "Sarah May" (68274688) 00:05:25.679 --> 00:05:36.689 And date home, which is a specific accessory use for a single family, or other residential use, um, and everything that we. 21 "Sarah May" (68274688) 00:05:36.689 --> 00:05:43.409 Are able to amend is contained within here, so we don't really have the ability to go outside of these guardrails. 22 "Sarah May" (68274688) 00:05:43.409 --> 00:05:50.969 Okay, so a little background on this amendment, um, what it can and can't do it's scope and the timeline. 23 "Sarah May" (68274688) 00:05:50.969 --> 00:05:58.949 Um, uh, so zoning is the, uh, process that the Dallas development code enables. 24 "Sarah May" (68274688) 00:05:58.949 --> 00:06:02.339 And, um, within our Dallas development code. 25 "Sarah May" (68274688) 00:06:02.339 --> 00:06:09.359 They have zoning districts, and within those districts, they establish what land uses are allowed. 26 "Sarah May" (68274688) 00:06:09.359 --> 00:06:14.639 And the zoning districts also defines where the structures can be built. 27 "Sarah May" (68274688) 00:06:14.639 --> 00:06:34.639

Um, and remember, it's where, um, not necessarily how so it doesn't have any life safety issues. That's all a different thing. And then visit development code can also make other reasonable, proportional and related requirements. So that, um, each land. 28 "Sarah May" (68274688) 00:06:34.639 --> 00:06:47.399 Would be more compatible with surrounding land uses, um, the development code cannot regulate operators of the same land use differently. So those are the things zoning doesn't really dictate. 37 "Sarah May" (68274688) 00:07:56.999 --> 00:08:17.249 Okay, so, just to be a broken record, the scope of our amendments are these daycare facilities, children, adults, and, uh, a small day home, which can occur within someone's residents. Um, it, we're not talking about public or private schools. 38 "Sarah May" (68274688) 00:08:17.249 --> 00:08:36.569 Uh, nursing homes, um, group dwelling units, or boarding houses. This is the living, uh, retirement, housing, community service centers. None of those are included within our scope, um, in our authorization. So that's not part of our discussion. Certainly those, those. 39 "Sarah May" (68274688) 00:08:36.569 --> 00:08:40.229 Factors come in in your daily life in the city. I'm sure. 40 "Sarah May" (68274688) 00:08:40.229 --> 00:08:45.809 Okay, so, for the for the timeline of this amendment, it all started. 41 "Sarah May" (68274688) 00:08:45.809 --> 00:09:02.669 December 15th, 2022, when city planning commission issued a 3 member memo and requested that staff, take a look at these uses and see what the appropriate zoning districts and other applicable regulations. Um, hence we are doing this session and yesterday session, and we've been reaching out to stakeholders and essentially a childcare providers and adult, take care providers, um, to get more information and more data, uh, which was also requested. 46 "Sarah May" (68274688) 00:10:03.839 --> 00:10:24.919 Okay, so while I'm switching gears and we're kind of talk about this, uh, accessory, use, called day homes next their current regulations and conditions. Um, so a day home is incidental to the primary use as a residents. So that's a lot of words to say, this will only happen in someone's home and it's basically. 47 "Sarah May" (68274688) 00:10:24.919 --> 00:10:32.939 A small childcare facility that the owner that lives there or not necessarily property owner, but the resident operates. 48 "Sarah May" (68274688) 00:10:32.939 --> 00:10:44.189 Um, and it's currently allowed by right in all districts, which also includes all of our residential districts. Um, the city code limits attendees to 10. 49 "Sarah May" (68274688) 00:10:44.189 --> 00:10:56.429 However, the state allows up to 12, and also, no parking is required for day homes because, um, most of the traffic generated is dropped off in the morning. 50 "Sarah May" (68274688) 00:10:56.429 --> 00:11:08.699 Basically, and picked up later on that night, um, most of the caregivers that are bringing the children here, aren't saying longer than, um, are not saying a long time. 51 "Sarah May" (68274688) 00:11:08.699 --> 00:11:20.339 Um, and we looked at some information on workday homes are currently located in Dallas, um, as licensed by the state. 52 "Sarah May" (68274688) 00:11:20.339 --> 00:11:26.429 And they have 3 different categories, um, the 1st, category limits kids to 3. 53 "Sarah May" (68274688) 00:11:26.429 --> 00:11:40.589 Um, so, since our definition of a day home says it has to have at least 4 children. Um, it is not technically considered as a day home in Dallas, but just, there's 18 of these in Dallas.

54 "Sarah May" (68274688) 00:11:40.589 --> 00:11:50.789 Um, and they have to have a license, um, and then the next 2 kinds are called a registered and a licensed childcare home, um, by the state.

55 "Sarah May" (68274688) 00:11:50.789 --> 00:12:00.149 And, uh, the registered variety, um, limits children limits it to 6 children. But in, in addition.

56 "Sarah May" (68274688) 00:12:00.149 --> 00:12:03.959 They, um, let me close this window.

57 "Sarah May" (68274688) 00:12:03.959 --> 00:12:19.709 Um, they can have 6 school age children after school. Um, and so there's only 46 of those in Dallas, and for the license who can have up to 12 for the state um, can care for children up to 24 hours, but obviously not overnight.

Um, so these are your kind of more traditional child care facilities they, uh, provide care training, education, custody and treatment or supervision for a person's under 14 years of age.

Um, and another big, uh, difference between this use and the previous
use is that it cannot the, the use cannot be used as a residence. Um,
so, uh, these are like your daycare centers where nobody's living

And spoiler alert.

63 "Sarah May" (68274688) 00:13:22.939 --> 00:13:30.689 The adult daycare facilities, um, require a specific use permit, but are allowed by a. 64 "Sarah May" (68274688) 00:13:30.689 --> 00:13:50.689 And, um, if you are able to pinpoint any red, tiny dots, those are and 4, uh, districts. So that's, um, our higher density, taller buildings, multi family districts and our office districts. And the reason why it's red is because these uses. 65 "Sarah May" (68274688) 00:13:50.689 --> 00:13:53.699 Are limited, um, or only. 66 "Sarah May" (68274688) 00:13:53.699 --> 00:13:57.989 Allowed to be a limited use, which means it can only occupy 10% of the building. 67 "Sarah May" (68274688) 00:13:57.989 --> 00:14:08.129 Um, otherwise it doesn't say an is required or anything, so it's basically prohibited, um, and all the dark gray areas kind of in the, in the middle. 68 "Sarah May" (68274688) 00:14:08.129 --> 00:14:12.479 Those are our plain development districts, so when we looked at. 69 "Sarah May" (68274688) 00:14:12.479 --> 00:14:18.389 Where the state has licenses for what they call a childcare program center. 70 "Sarah May" (68274688) 00:14:18.389 --> 00:14:38.389 Which is probably closest to, um, our childcare facilities we found that there are 281 in the city and however, it is important to know that some of these kind of use, like a loophole, if you will in our development code, and are not considered a childcare facility. Um, either. 71 "Sarah May" (68274688) 00:14:38.389 --> 00:14:55.739 Here, because they are located within a public or private school, um, many of, you know, offers some Pre K programs. Um, so obviously they would have a license, but since it's in a school, the land use is not considered a childcare facility is considered a public or private school.

Um, and, uh, as you can tell, there's really not that much multi family zoning in the city. It is primarily. 80 "Sarah May" (68274688) 00:16:07.499 --> 00:16:13.979 Single family, duplex, townhome, but honestly primarily single family largely single family. 81 "Sarah May" (68274688) 00:16:13.979 --> 00:16:33.979 The gray also is PTs and, uh, all the pins that you see here are where we have specific use permits for a childcare facility, are the red ones where it's only for a childcare facility. The blue ones are for child care facility. That's with the school.

82 "Sarah May" (68274688) 00:16:33.979 --> 00:16:44.669 So, yeah, technically those are, uh, just a school landings and not necessarily considered child care, um, facilities on their own. 83 "Sarah May" (68274688) 00:16:44.669 --> 00:16:48.809 And when we looked at, um. 84 "Sarah May" (68274688) 00:16:48.809 --> 00:17:08.809 Uh, where we have, and what zoning district they are remember, since they only require an in residential district. Um, I did an analysis of our base owning residential districts. Um, and, uh, single family had the most at 80, um, childcare. 85 "Sarah May" (68274688) 00:17:08.809 --> 00:17:22.919 Centers from the state and out of those 80 only 20% add a specific use permit for a childcare facility. Um, and overall in all residential, it came out to 26%. Um. 86 "Sarah May" (68274688) 00:17:22.919 --> 00:17:37.139 So, I, I know that we think that it's that having an is incredibly important, but we only have 26% of our facilities, have an, um. 87 "Sarah May" (68274688) 00:17:37.139 --> 00:17:47.789 Overall city wide, um, there's only 37 that includes the with schools at a 281 facility so only about 13%. 88 "Sarah May" (68274688) 00:17:47.789 --> 00:17:53.159 Of child care facilities currently have so they're finding some way to get around it. 89 "Sarah May" (68274688) 00:17:53.159 --> 00:17:58.589 Probably with a church or inside sometimes with within a school. 90 "Sarah May" (68274688) 00:17:58.589 --> 00:18:05.939 Okay, so there's a lot of literature out there that says that there's a, uh, um. 91 "Sarah May" (68274688) 00:18:05.939 --> 00:18:12.359 A big need for childcare. It's not just Dallas. It's the state of Texas and it's the country. 92 "Sarah May" (68274688)

00:18:12.359 --> 00:18:32.359 Um, but in Texas specifically, according to the census and, um, Texas, health and Human Services, there's only capacity for 37 of children under 5 in Dallas. And that includes all the in home child care facilities are allowed by right currently, um, the image on. 93 "Sarah May" (68274688) 00:18:32.359 --> 00:18:51.059 Right of Dallas is from childcare desert, started work and if you have a chance to go, take a look at their website, it's really interactive and interesting. Um, but the dark orange, um, areas in Dallas are areas where they found, um. 94 "Sarah May" (68274688) 00:18:51.059 --> 00:19:04.259 Childcare opportunities to be scarce. Um, and I think that was the methodology was number of children under 5, and how many slots are available and I think. 95 "Sarah May" (68274688) 00:19:04.259 --> 00:19:11.309 Whenever, um, it was under 30% of capacity, or maybe under 50, I'm not sure. 96 "Sarah May" (68274688) 00:19:11.309 --> 00:19:14.789 It it got rated as as scarcity. 97 "Sarah May" (68274688) 00:19:14.789 --> 00:19:22.079 So, um, okay, so switching to adult bigger now, trying to go fast. Um. 98 "Sarah May" (68274688) 00:19:22.079 --> 00:19:28.469 The definition in our development code is very similar to childcare facility. 99 "Sarah May" (68274688) 00:19:28.469 --> 00:19:37.859 Um, the 1 big difference is that as for person's 18 years of age or older, um, instead of the 14 and under. 100 "Sarah May" (68274688) 00:19:37.859 --> 00:19:42.539 For the childcare, so sneak peek that there's an age gap in here. 101 "Sarah May" (68274688) 00:19:42.539 --> 00:19:52.919 Um, uh, the same districts or the are the same. So we still have our by right? Uh, by and limited.

a 100,000 dollars or more.
