The City Contractor installs water connections for **all** single family dwellings, duplexes, individually owned businesses, and churches with a 1" or smaller water service.

The City Contractor can install 1.5" & 2" water service connections for residential customers only

All other water services will be installed by the developer/customers bonded contractor and include an **inspection fee of \$275 per tap payable to the City of Dallas. (See Page 2)**

Water meters installed by the City Contractor can take up to 8 weeks or longer from the date the customer calls to the set up an appointment for meter installation.
