SELF-CERTIFICATION PROVIDER PLAN REVIEW PROGRAM

PURPOSE

The Development Services Department (DSD) created this Service First Bulletin (SFB) 103 to provide customers with an additional option of fast-tracking qualifying projects through the plan review process. The program allows property owners and design professionals to take control of their projects while ensuring compliance with local building codes and regulations. This initiative aims to reduce plan review timelines while maintaining the highest safety and compliance standards. This SFB is effective February 15th, 2024.

SCOPE

The Self-Certification Program simplifies the building permit plan review process by allowing Self-Certification Providers (SCP) to self-certify their own projects and expedite approvals for certain and qualifying construction and renovation projects. The following outlines project eligibility, code professional requirements, application request process, and fees.

PROJECT ELIGIBILITY CRITERIA

The following qualifying projects may be submitted through the Self-Certification Program.

- ❖ New one-and-two family dwelling units (all square footage sizes)
The following parameters have been set to qualify for this service:
 - Maximum of three (3) stories (no basements)
 - Must not be in a special overlay district (Historic, Floodplain, Conservation, Complex PD, Shared Access, etc.)
 - Property must be platted or have early release approvals.
- ❖ Commercial remodels and interior finish-out projects less than 5,000 square feet (Business Group “B” and Mercantile Group “M” occupancies only)

The SCP may certify compliance for all technical building, mechanical, electrical, plumbing, energy/green, and fire related plan review trades. Program exclusions would include any

of the following disciplines:

- ❖ Landmark Preservation
- ❖ Historical/Conservation District
- ❖ Floodplain
- ❖ Transportation
- ❖ Zoning
- ❖ Fire Protection Systems (Sprinklers, Alarms, etc.)
- ❖ Specialized Overlays and Planned Developments
- ❖ Board of Adjustment requests

PROJECT ELIGIBILITY CRITERIA

The program requires the SCP to meet specific qualifications, ensuring that only those with the necessary expertise may self-certify projects. Registrants shall submit the Self-Certification Professional Registration Application along with all the following required documentation:

1. Self-Certification Professional Registration Application
2. Statement of Qualifications
3. Resume indicating relevant work history
4. Copies of:
 - a. Texas Professional Engineer's license; or
 - b. Texas Registered Architect license; or
 - c. International Code Council Building Official Certification
5. Self-Certified Professional Training and Experience Verification Form

The following design and code professionals may register as Self-Certification Providers:

- ❖ Texas Licensed Architects
- ❖ Texas Licensed Professional Engineers
- ❖ International Code Council (ICC) Certified Building Officials (CBO)
- ❖ Have experience in ensuring code compliance for a minimum of at least three (3) years and,
- ❖ Be responsible for compliance with the City of Dallas Codes/Ordinances.

PROJECT ELIGIBILITY CRITERIA

Anyone seeking to participate as an SCP Program shall submit to the Building Official all required documentation outlined on the [Self-Certification webpage](#). Below is a list of key components needed to become an approved registered SCP:

- ❖ Certificate of Insurance
- ❖ Indemnification/Acknowledgement Forms
- ❖ Designation "Professional In-Charge" and "Technical Point of Contact"
- ❖ \$500.00 nonrefundable Annual Registration Fee for each Self Certificate Professional

- ❖ \$200.00 nonrefundable Annual Registration Fee for each additional registered employee providing plan review services
- ❖ Annual DSD Training Session

FEES AND INSPECTIONS

The Building Official shall assess plan review fees based on the following schedule when an SCP certifies plan review compliance:

- ❖ New one-and-two family dwelling units (all square footages) will be charged a maximum of 35% of the current plan review and permit fee.
- ❖ “B”/“M” occupancy projects less than 5,000 square feet will be charged a maximum of a of 50% of the current plan review and permit fee.

All additional standalone review fees that are performed by DSD (Parking Agreement Reviews, Special Zoning Overlays, etc.) shall be assessed at rate of \$100.00 per hour/per trade, or as outlined in [Chapter 52, Administrative Procedures for the Construction Codes](#).

Applicants may only utilize only one SCP to perform all plan reviews. For informational purposes only, DSD will advertise on the department website, a list of “Registered” Self-Certification Providers and will post names, firms, and code professional contact information. The Department reserves the right to perform all required inspections.
