HOME OCCUPATION DECLARATION

The City of Dallas requires a contractor to submit proof of an established place of business. If that place of business is within the city, a certificate of occupancy must be secured as required in the *Dallas Development Code*. In lieu of a certificate of occupancy, a contractor may declare that his residence is the place of business.

Home occupation definition: an occupation that is incidental to the primary use of the premises as a residence and conducted on the residential premises by the resident of the premises.
