

# **Summary of Steering Committee Meeting #2**

## **PD No. 15 Authorized Hearing**

- I. **Introduction of City Staff and Steering Committee Members**  
Staff opened the meeting with introductions and welcomed the steering committee members and community. Steering committee members introduced themselves and their connection to the authorized hearing area.
  
- II. **Meeting Procedures and Expectations**  
Staff reviewed the steering committee meeting procedures and expectations. The steering committee meetings will be held with staff to review the current zoning in the area, the intent or direction of possible changes, and to develop proposed zoning amendments.
  
- III. **Review of 1st Steering Committee Meeting**  
Staff reviewed the previous steering committee meeting and expanded on questions and comments that have been received to date. Staff explained that all meeting materials and information documents will be posted to website throughout the authorized hearing process:
