SUBJECT

An amendment to the City of Dallas Central Business District Streets and Vehicular Circulation Plan to change the operational characteristics of Lamar Street from Elm Street to Young Street from a southbound three-lane roadway and a northbound three-lane roadway in 78-100 feet of right-of-way and 66 feet of pavement to a southbound two-lane roadway and a northbound two-lane roadway in 78-80 feet of right-of-way and 40-60 feet of pavement.

BACKGROUND

The Office of Economic Development has requested a Thoroughfare Plan Amendment to change the operational characteristics of Lamar Street between Elm Street and Young Street. The proposed amendment would match the roadway operation at non-peak hours with two-lanes northbound and two-lanes southbound and parking. Current operation during the peak hours is two-lanes northbound and two-lanes southbound, with peak-hour parking restrictions on both sides of the street.

The scope of the project is to design a sustainable roadway that aligns with the City's Complete Streets Vision to create roadways that accommodate all modes and are comfortable for all users. Unrestricted parking, widened sidewalks, pedestrian lighting, improved accessibility with barrier free ramps, and reduced crossing distances at intersections are all included in the project. Other project elements include the addition of trees, decorative pavement at cross-walks, benches, and bike parking. The sum of these improvements will improve the pedestrian realm.

The Downtown 360 Plan (2011) identified Lamar Street as one of five primary Focus Areas in Downtown where physical and economic improvements have the potential to activate development opportunities. The 360 Plan recommends policy and urban design modifications for the Lamar Corridor that will support walkability, existing development, and attract future growth. Project implementation will occur through a partnership between the City of Dallas and the North Central Texas Council of Governments.

The project is supported by Downtown Dallas, Inc. and other stakeholders in the corridor. El Centro Community College is supportive of the project and the modifications that will be made to improve ADA accessibility. Staff will work with the campus to create a drop-off zone for students.

Lee Engineering conducted a traffic study and concluded that the proposed amendment is feasible. The study concluded that with signal timing modifications, the intersection capacity will operate at acceptable levels of service, D or better, in 2035 with the proposed four-lane configuration.

STAFF RECOMMENDATION

Staff recommends approval to the City of Dallas Central Business District Streets and Vehicular Circulation Plan to change the operational characteristics of Lamar Street from Elm Street to Young Street from a southbound three-lane roadway and a northbound three-lane roadway in 78-100 feet of right-of-way and 66 feet of pavement to a southbound two-lane roadway and a northbound two-lane roadway in 78-80 feet of right-of-way and 40-60 feet of pavement.

PROPOSED COUNCIL AGENDA: August 9, 2017

PROJECT: An amendment to the City of Dallas Central Business District Streets and Vehicular Circulation Plan to change the operational characteristics of Lamar Street from Elm Street to Young Street from a southbound three-lane roadway and a northbound three-lane roadway in 78-100 feet of right-of-way and 66 feet of pavement to a southbound two-lane roadway and a northbound two-lane roadway in 78-80 feet of right-of-way and 40-60 feet of pavement.




Lamar Street between Elm Street and Main Street*
