REQUEST

Amendment to the City of Dallas Thoroughfare Plan to change the dimensional classification of Herbert Street between West Commerce Street and Muncie Avenue from a special two-lane undivided roadway (SPCL 2U) in 56 feet of right-of-way to a special four-lane undivided roadway (SPCL 4U) in 90 feet of right-of-way with bicycle facilities.

BACKGROUND

City of Dallas Public Works Department has requested an amendment to the City of Dallas Thoroughfare Plan to change the dimensional classification of Herbert Street between West Commerce Street and Muncie Avenue. Herbert Street is currently on the Thoroughfare Plan as a Community Collector, to be constructed as a two-lane undivided roadway in 56 feet of right-of-way. Herbert Street has been constructed to Thoroughfare Plan standards north of Broadway Avenue to Singleton Boulevard, however, has not been constructed south of Broadway Avenue across the Union Pacific Railroad (UPRR) tracks to West Commerce Street.

In 2011, City Council adopted the West Dallas Urban Structure Guidelines, which envisioned three new north-south streets connecting West Commerce Street and Singleton Boulevard under the UPRR tracks between Sylvan Avenue and Beckley Avenue: Bataan Street, Herbert Street, and Amonette Street. Funding was allocated to the West Dallas Gateway project (also known as the Three Hole Punch project) in the 2012 Bond to construct these three new streets. Since then, the City of Dallas Public Works Department has been coordinating with the North Central Texas Council of Governments and the UPRR on options to construct the project, and there has been consensus for only constructing one new street that will travel under the UPRR tracks to connect West Commerce to Singleton: Herbert Street. The StoryBuilt Traffic Impact Analysis (March 2021) found that traffic can be successfully incorporated into the surrounding roadway network with only the extension of Herbert under the UPRR tracks. Bataan Street was removed from the Thoroughfare Plan on August 25, 2021, and staff have received an application to remove Amonette Street from the Thoroughfare Plan.

The West Dallas Gateway project to construct Herbert Street will also construct

extension of Muncie Avenue eastward to connect to Bataan, Herbert, and Amonette Street, thereby connecting the other two streets that were originally intended to traverse the UPRR tracks to the new Herbert Street connection north of the UPRR tracks. . From the new intersection with Muncie Avenue, the City of Dallas Public Works Department is requesting that Herbert Street continue south under the UPRR to West Commerce Street as a four-lane undivided concrete roadway with dedicated bicycle lanes, sidewalks, curb, and gutters. The City of Dallas has acquired or has been dedicated the required 90-foot right-of-way for the construction of Herbert. Due to right-of-way constraints north of Muncie Avenue as well as the anticipated dispersal of traffic, Herbert Street is proposed to remain a special two-lane undivided roadway north of Muncie Avenue.

No driveways or on-street parking will be affected by this proposed Thoroughfare Plan amendment.

STAFF RECOMMENDATION

Staff recommends approval of the requested amendment to the City of Dallas Thoroughfare Plan to change the dimensional classification Herbert Street between West Commerce Street and Muncie Avenue from a special two-lane undivided roadway (SPCL 2U) in 56 feet of right-of-way to a special four-lane undivided roadway (SPCL 4U) in 90 feet of right-of-way with bicycle facilities.

REQUEST

Amendment to the City of Dallas Thoroughfare Plan to change the dimensional classification of Herbert Street between West Commerce Street and Muncie Avenue from a special two-lane undivided roadway (SPCL 2U) in 56 feet of right-of-way to a special four-lane undivided roadway (SPCL 4U) in 90 feet of right-of-way with bicycle facilities

BACKGROUND:

- The existing Thoroughfare Plan designation is special two-lane undivided roadway in 56 feet of right-of-way (SPCL 2U), and the classification is Community Collector.
- Proposed dimensional classification would change the 56 feet of right-of-way to 90 feet of right-of-way.
- The City owns the required 90 feet of right-of-way for Herbert south of Muncie Avenue.
- Herbert Street has been constructed to Thoroughfare Plan standards north of Broadway Avenue to Singleton Boulevard but has not been constructed south of south of Broadway Avenue across the UPRR tracks to West Commerce Street.
- Due to constraints north of Muncie Avenue, the Thoroughfare Plan will not be changed from the two-lane undivided roadway in 56 feet of right-of-way (SPCL 2U).
- Herbert Street is on the City of Dallas Bike Plan.
- Herbert Street was placed on the City of Dallas Thoroughfare Plan on June 19, 2013, Ordinance number 29045.
- This area is part of PD 714, Subdistrict 1A. This subdistrict is for medium density mixed-use.
- The West Dallas Urban Structure and Guidelines, which was adopted by City Council
 on March 11, 2011, proposed three new north-south street connections under the
 Union Pacific Railroad (UPRR) tracks to connect Singleton Boulevard and West

Commerce Street. Those new street connections were, from east to west: Amonette Street, Herbert Street, and Bataan Street.

- The City of Dallas Public Works Department is in design for Herbert Street, and working with UPRR to approve the proposed design and gain access under the tracks.
- Bataan Street was removed from the Thoroughfare Plan on August 25, 2021.
- An application was received on January 6, 2022 to remove Amonette Street from the Thoroughfare Plan.



REQUEST

Amendment to the City of Dallas Thoroughfare Plan to delete Amonette Street between West Commerce Street and Singleton Boulevard from the Thoroughfare Plan.

BACKGROUND

James Lee, 255 West Commerce property owner, has requested an amendment to the City of Dallas Thoroughfare Plan to delete Amonette Street between West Commerce Street and Singleton Boulevard from the Thoroughfare Plan. Amonette Street is currently on the Thoroughfare Plan as a Community Collector, to be constructed as a two-lane undivided roadway in 54 feet of right-of-way. Amonette Street has been constructed to Thoroughfare Plan standards north of Broadway Avenue on the northside of the Union Pacific Railroad (UPRR) train tracks to Singleton Boulevard. It has not been constructed south of the UPRR tracks to West Commerce Street.

In 2011, City Council adopted the West Dallas Urban Structure Guidelines, which envisioned three new north-south streets connecting West Commerce Street and Singleton Boulevard under the UPRR tracks between Sylvan Avenue and Beckley Avenue: Bataan Street, Herbert Street, and Amonette Street. Funding was allocated to the West Dallas Gateway project (also known as the Three Hole Punch project) in the 2012 Bond to construct these three new streets. Since then, the City of Dallas Public Works Department has been coordinating with the North Central Texas Council of Governments and the UPRR on options to construct the project, and there has been consensus for only constructing one new street that will travel under the UPRR tracks to connect West Commerce to Singleton: Herbert Street. The StoryBuilt Traffic Impact Analysis (March 2021) found that traffic can be successfully incorporated into the surrounding roadway network with only the extension of Herbert under the UPRR tracks. Bataan Street was removed from the Thoroughfare Plan on August 25, 2021.

The City does not currently have the required right-of-way or funding to construct Amonette Street south of the UPRR. If Amonette Street is removed from the Thoroughfare Plan, the existing section of Amonette Street north of the UPRR tracks would be assigned a classification of "local road" in the City streets inventory.

No driveways or on-street parking will be affected by this proposed Thoroughfare Plan amendment.

STAFF RECOMMENDATION

Staff recommends approval of the requested amendment to delete Amonette Street from West Commerce Street to Singleton Boulevard from the Thoroughfare Plan.


