#### REQUEST

Amendment to the City of Dallas Thoroughfare Plan to remove Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard.

### BACKGROUND

The City of Dallas Department of Transportation and Public Works has requested an amendment to the City of Dallas Thoroughfare Plan to remove Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard. Colonial Avenue is on the Thoroughfare Plan as a community collector with the designation of a two-lane undivided roadway within 56 feet of right-of-way and 36 feet of pavement (S-2-U).

As part of Texas Department of Transportation's (TxDOT) S.M. Wright Freeway project improvements, Colonial Avenue between Pennsylvania Avenue and Peabody Avenue will be closed to vehicular and pedestrian traffic. While vehicular and pedestrian traffic will still be permitted between Peabody Avenue and Martin Luther King Jr. Boulevard, the lack of through access between Pennsylvania Avenue and Martin Luther King Jr. Boulevard, the Thoroughfares on the Thoroughfare Plan) means that Colonial Avenue will no longer function as a collector thoroughfare south of Martin Luther King Jr. Boulevard.

St. Philip's School and Community Center has applied for an abandonment of Colonial Avenue between Pennsylvania Avenue and Peabody Avenue to make improvements to their campus. For a property owner to abandon this roadway, Colonial Avenue must first be formally removed from the Thoroughfare Plan.

Removing Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard from the Thoroughfare Plan will not result in the removal of the roadway from the local roadway network until the abandonment requested by St. Philip's is approved by City Council ordinance. Portions of Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard that will not be abandoned will not be removed from the local roadway network and will be regulated by City of Dallas design standards for local streets.

### **STAFF RECOMMENDATION**

Staff recommends approval to amend the City of Dallas Thoroughfare Plan to remove Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard.



**<u>REQUEST</u>**: Amendment to the City of Dallas Thoroughfare Plan to remove Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard.


#### BACKGROUND:

- As part of the S.M. Wright Freeway project, the Texas Department of Transportation (TxDOT) is currently in the process of putting curbs in on Colonial Avenue, eliminating Colonial Avenue's direct connection to Pennsylvania Avenue. The portion of Colonial that is being closed to vehicular access as part of TxDOT's project is shown in red in the image below. Because the Thoroughfare Plan is intended to preserve network connectivity of collector and arterial roadways, Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. may be removed from the plan without adverse impacts because it will no longer provide connectivity between collector and arterial roadways. The plans for the S.M. Wright Freeway project were reviewed and approved by former engineers in the City of Dallas Department of Transportation. However, a Thoroughfare Plan amendment was never pursued at that time.
- St. Philip's School and Community Center has applied for an abandonment of Colonial Avenue between Pennsylvania Avenue and Peabody Avenue for improvements to their campus. For a property owner to abandon this roadway, Colonial Avenue will need to be formally removed from the Thoroughfare Plan.





- Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard is on the City of Dallas' High Injury Network (HIN).
- Colonial Avenue is not on the City of Dallas 2011 Bike Plan nor is it on the proposed 2024 Bike Plan.
- Route 13, a high-frequency DART bus route, runs along Colonial Avenue between Pennsylvania Avenue and Martin Luther King Jr. Boulevard.
- Colonial Avenue is designated as a Mixed-Use Street by the City of Dallas Complete Streets Design Manual.
- 24 property owners are in the notification area.




# **Colonial Cross-Sections**

# <u>REQUEST</u>

Amendments to the City of Dallas Thoroughfare Plan to remove: (1) Forest Lane between Reeder Road and Harry Hines Boulevard; and (2) Forest Lane between Harry Hines Boulevard and Josey Lane.

## BACKGROUND

The City of Dallas Department of Transportation and Public Works has requested amendments to the City of Dallas Thoroughfare Plan to remove (1) Forest Lane between Reeder Road and Harry Hines Boulevard; and (2) Forest Lane between Harry Hines Boulevard and Josey Lane. The section of Forest Lane between Reeder Road and Harry Hines Boulevard is on the Thoroughfare Plan as a community collector with the designation of a four-lane undivided roadway in 60 feet of right-of-way and 44 feet of pavement (S-4-U). The section of Forest Lane between Harry Hines Boulevard and Josey Lane is on the Thoroughfare Plan as a principal arterial with the designation of a four-lane undivided roadway in 60 feet of pavement (S-4-U). The proposal is to remove these segments of Forest Lane from the Thoroughfare Plan.

In 2015, the Texas Department of Transportation (TxDOT) completed a project on the I-635 corridor between I-35E and US 75 known as "LBJ Express/IH 635 Managed Lanes" project. This project impacted the operations of Forest Lane between Harry Hines Boulevard and Josey Lane. For multiple segments of this roadway, Forest Lane now operates as one-way instead of two-way. It also functions similarly to a frontage road as a result of the project improvements.

Furthermore, TxDOT is currently in the planning process for a project aimed at improving the I-635/I-35E interchange. Based on the current draft of this project, all of Forest Lane between Reeder Road and Josey Lane will function as a one-way continuous frontage road.

Due to the way in which I-635 was constructed and due to anticipated future improvements to the I-635/I-35E interchange, Forest Lane's current Thoroughfare Plan designation between Reeder Road and Josey Lane is not feasible to implement now or in the future. Because of this and because some segments of Forest Lane between Reeder Road and Josey Lane are within TxDOT right-of-way, staff is recommending this segment of Forest Lane be removed from the Thoroughfare Plan. Removing the roadway

from the Thoroughfare Plan will not result in the removal of the roadway from the local roadway network or abandon the existing public right-of-way. It is also consistent with the treatment of other frontage roads in the City of Dallas.

## STAFF RECOMMENDATION

Staff recommends approval to amend the City of Dallas Thoroughfare Plan to remove: (1) Forest Lane between Reeder Road and Harry Hines Boulevard; and (2) Forest Lane between Harry Hines Boulevard and Josey Lane.



**REQUEST:** Amendments to the City of Dallas Thoroughfare Plan to remove: (1) Forest Lane between Reeder Road and Harry Hines Boulevard; and (2) Forest Lane between Harry Hines Boulevard and Josey Lane.


#### BACKGROUND:

- Forest Lane between Harry Hines Boulevard and Josey Lane is on the 2011 City of Dallas Bike Plan. No segment of Forest Lane between Reeder Road and Josey Lane is on the proposed 2024 Bike Plan.
- In 2015, the Texas Department of Transportation (TxDOT) completed improvements for the LBJ Express/IH 635 Managed Lanes project, which resulted in Forest Lane being converted from two-way operations to one-way operations in certain areas between Reeder Road and Josey Lane. Two-way operations along the entire stretch of Forest Lane between Reeder Road and Josey Lane are not feasible because of the impacts of this project. The City of Dallas Thoroughfare Plan does not identify and protect one-way frontage roads in TxDOT right-of-way.


 TxDOT is currently in the planning process for a project to improve the I-635/I-35E interchange. Based on the current draft concept for this project, Forest Lane will operate as a continuous one-way frontage road between Emerald Street and Harry Hines Boulevard if the project comes to fruition. The Thoroughfare Plan does not identify and protect one-way frontage roads.



- Removing Forest Lane from the Thoroughfare Plan will not abandon the existing public right-of-way.
- Forest Lane between Reeder Road and Josey Lane is designated as a Commercial Street by the City of Dallas Complete Streets Design Manual.





**Current Thoroughfare Plan Proposed Designation** – 4-lane undivided roadway (S-4-U) within 60 feet of right-of-way and 44 feet of pavement



Existing Typical Section from Reeder Road to Harry Hines Boulevard – 4-lane divided roadway



Existing Typical Section from Harry Hines Boulevard to Grissom Lane – One-way operation with 2 eastbound lanes and a sidewalk on one side of the roadway

Existing Typical Section from Grissom Lane to eastern Home Depot driveway – 2-lane undivided roadway with buffered sidewalk on one side of the roadway

Existing Typical Section from eastern Home Depot driveway to Josey Lane – 4-lane divided roadway with sidewalks on both sides of the roadway
