## <u>REQUEST</u>

Amendments to the City of Dallas Thoroughfare Plan to remove (1) Wycliff Avenue between Harry Hines Boulevard and Market Center Boulevard and (2) Wycliffe Avenue between Market Center Boulevard and Interstate Highway 35 East.

#### BACKGROUND

The City of Dallas Department of Transportation and Public Works has received a request from AM Campus LP to amend the City of Dallas Thoroughfare Plan by removing the following segments of Wycliff Avenue:

- 1. Between Harry Hines Boulevard and Market Center Boulevard
- 2. Between Market Center Boulevard and Interstate Highway 35E (IH 35E)

## Harry Hines Boulevard to Market Center Boulevard

The Thoroughfare Plan designates this segment of Wycliff Avenue as a Principal Arterial (S-6-D) in 107 feet of right-of-way. The segment extends east from Market Center Boulevard and generally follows the alignment of an existing drive that serves the Trade Mart buildings, then continues northward to form the intended fourth leg of the intersection at Harry Hines Boulevard and Wycliff Avenue. However, the City does not currently possess right-of-way for this segment, and no changes are anticipated to its existing or future use.

Additionally, due to physical constraints posed by the TRE and the elevated DART Rail lines, construction of this segment is not considered feasible. Therefore, the applicant is requesting its removal from the Thoroughfare Plan to reflect its continued use as a private drive.

#### Market Center Boulevard to IH 35E

The Thoroughfare Plan designates this segment of Wycliff Avenue as a Principal Arterial (S-4-U) in 60 feet of right-of-way. The alignment generally follows an existing parking access road that serves the Market Hall site, providing internal circulation to

various parking lots and garages on the property. However, the City does not currently own or maintain public right-of-way for this segment.

The north-south section of this segment, extending from IH 35E, consists of a two-lane undivided roadway, while the east-west section leading to Market Center Boulevard is a three-lane undivided roadway with one westbound lane and two eastbound lanes.

The property is proposed for redevelopment with a use expected to generate low traffic volumes. A traffic impact assessment indicates that existing traffic volumes are minimal and consists of travelers accessing the Children's Medical Center from Market Center Boulevard, and those traveling to and from Wycliff–Sylvan Avenue south of IH-35E. The assessment concludes that the projected traffic volumes can be accommodated by a roadway of lower a functional classification, not designated in the Thoroughfare Plan, or can be absorbed by the surrounding street network.

#### **STAFF RECOMMENDATION**

Staff recommends approval to amend the City of Dallas Thoroughfare Plan to remove (1) Wycliff Avenue between Harry Hines Boulevard and Market Center Boulevard and (2) Wycliffe Avenue between Market Center Boulevard and Interstate Highway 35 East.


**<u>REQUEST</u>**: Amendments to the City of Dallas Thoroughfare Plan to remove (1) Wycliff Avenue between Harry Hines Boulevard and Market Center Boulevard and (2) Wycliffe Avenue between Market Center Boulevard and Interstate Highway 35 East.

## BACKGROUND:

- Wycliff Avenue between Harry Hines Boulevard and Market Center Boulevard
  - Designated as a Principal Arterial (S-6-D) in 107 feet of right-of-way.
  - Currently operates as a two-lane private drive with a parking lane on the north side serving the Trade Mart buildings, with no changes anticipated to its existing or future use.
  - The City does not currently possess right-of-way for this segment
  - Constructing segment is not feasible due to the physical constraints posed by the TRE and the elevated DART Rail lines.
- Wycliff Avenue between Market Center Boulevard and IH 35E
  - Designated as a Principal Arterial (S-4-U) in 60 feet of right-of-way.
  - Currently operates as a parking access road that serves the Market Hall site, providing internal circulation to various parking lots and garages on the property.
  - The City does not currently own or maintain public right-of-way for this segment.
  - The property is proposed for redevelopment with a use expected to generate low traffic volumes. A Traffic Impact Assessment indicates that the projected traffic can be accommodated by a roadway of a lower functional classification or absorbed by the surrounding street network.

West of Market Center	3,300	3,900


Bike Plan: Both segments are designated as potential bike routes in the 2011 Bike Plan and proposed as potential bike routes in the draft bike plan network.




#### Wycliff Avenue Cross-Sections

<u>Current Thoroughfare Plan Designation</u> – Standard six-lane divided principal arterial roadway in 107 feet of right-of-way (S-6-D).




**Existing Operation** – Two-lane drive with a parking lane on the north side.





## 2. Wycliff Avenue between Market Center Boulevard and IH 35E

<u>Current Thoroughfare Plan Designation</u> – Standard four-lane undivided principal arterial roadway in 60 feet of right-of-way (S-4-U).



Existing Operation (north - south) - Two-lane undivided roadway.



Existing Operation (east-west) - Three-lane undivided roadway.
