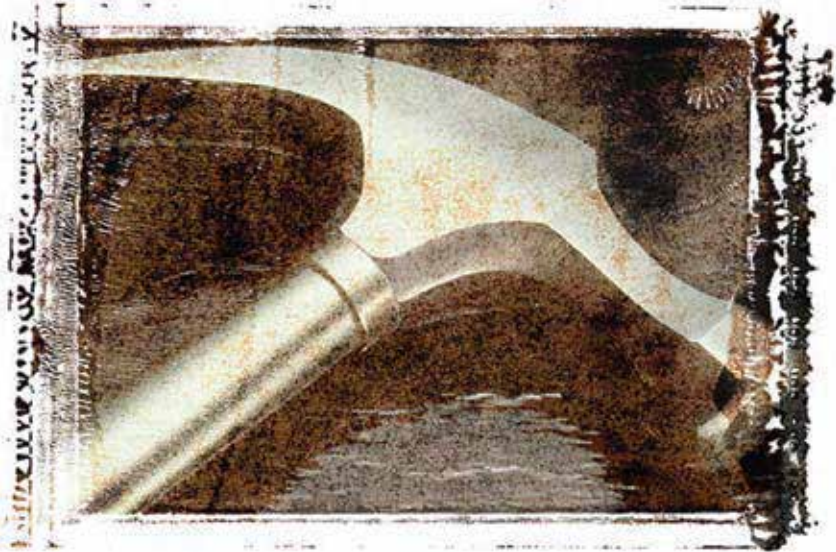

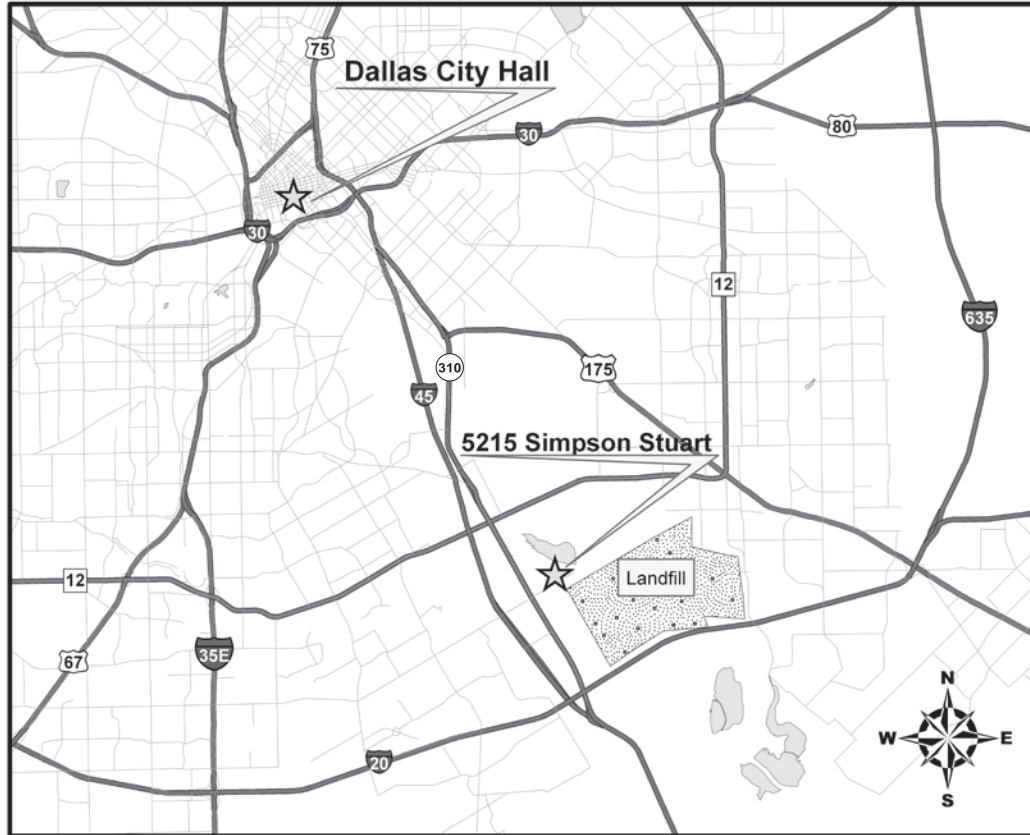

**Directions to Eco Park: (located 10 miles south of Downtown Dallas)**

**From North (Dallas):**

Take I-45 (US Hwy 75) South  
Exit Simpson Stuart Rd. - go East (turn left)  
Pass State Hwy 310 and the railroad tracks  
The Eco Park building will be to your left (north side of the road)  
Entrance is on the North side (back side) of the building

**From South (Dallas):**

Take I-45 North  
Exit Simpson Stuart Rd. - go East (turn right)  
Pass State Hwy 310 and the railroad tracks  
The Eco Park building will be to your left (north side of the road)  
Entrance is on the North side (back side) of the building of building)

**From West (Fort Worth / Mid-Cities):**

Take I-20 East  
Exit at I-45 North  
Exit Simpson Stuart Rd. - go East (turn right)  
Pass State Hwy 310 and the railroad tracks  
The Eco Park building will be to your left (north side of the road)  
Entrance is on the North side (back side) of the building

**From East (Mesquite):**

Take I-20 West  
Exit I-45 North  
Exit Simpson Stuart Rd. - go East (turn right)  
Pass State Hwy 310 and the railroad tracks  
The Eco Park building will be to your left (north side of the road)  
Entrance is on the North side (back side) of the building
