
Alison Grinter Allen - DISTRICT 9

His community involvement includes serving on the Dallas County Grand Jury and the boards of the Suicide and Crisis Center (as Board President) and Community Partners of Dallas. He was previously appointed by the Dallas City Council to the Finance and Housing Board. In 2017, he was appointed to the Citizens Police Review Board, later the Community Police Oversight Board, and

reappointed in 2023 by Council member Gay Donnell Willis.

Brandon Friedman - DISTRICT 14

Brandon Friedman started his career as an infantry officer in the U.S. Army's 101st Airborne Division. In March 2002, he led a platoon into Afghanistan's Shah-e-Kot Valley during Operation Anaconda, engaging Taliban and al-Qaeda fighters. A year later, he commanded troops in the invasion of Iraq, participating in combat and counterinsurgency operations. He left active duty in

2004 and received two Bronze Stars for his service. From 2007 to 2009, Friedman served as vice chairman and spokesperson for VoteVets.org, a non-profit organization promoting veteran candidates. In 2007, he authored The War I Always Wanted, a memoir about his combat experiences, recognized by Army Times as a top military book. In 2009, he became the first director of digital media at the Department of Veterans Affairs, aiming to enhance online veteran interaction. After leaving the VA in 2012, he joined Fleishman Hillard as a vice president and later worked at the Department of Housing and Urban Development. In 2017, he co-founded Rakkasan Tea Company to sell teas from post-conflict areas.
