Summary of Federal Directives



- 1. Diversity, Equity, and Inclusion (DEI)

 EO 14173 Ending Illegal
 Discrimination and Restoring
 Merit-Based Opportunity;
 Federal Grant Requirements
- 2. Immigration Compliance EO 14218 – Taxpayer Subsidization of Open Borders; Federal Grant Requirements
- 3. Minority & Women Business Enterprise (M/WBE) Contracts 2 CFR § 200.321, EO 14173 Guidance and Federal Grant Requirements

The City cannot operate programs that promote or advance illegal DEI ideology in violation of federal antidiscrimination laws.

The City cannot allocate contracts or benefits based on suspect classifications, including:

Race, sex, national origin, or religion. (Permissible classifications: veteran, disability, and socioeconomic status)

The City cannot operate programs that benefit or incentivize illegal immigration.


HUD funding may not be used in ways that by design or effect subsidize or promote undocumented residency. The City must assist DHS requests to locate, investigate, and deport undocumented residents.

While federal law requires consideration (i.e., inclusion and access) of small, minority-, women-, and veteran-owned businesses, the City cannot use race, sex, national origin, or religion as scoring criteria or add points in proposal evaluations.



Federal Grant Compliance Timeline & Summary





City Council June 25, 2025, Resolution



Council Resolution No. 25-1081 (June 25, 2025)

Directed the City Manager to:

- Review and evaluate City programs and policies to determine whether any adjustments may be necessary.
- Take any temporary operational actions necessary to ensure city programs and policies are in compliance with federal directives.
- **Brief** City Council no later than August 20, 2025, and present recommendations on any necessary changes.



Federal Compliance & Organizational Realignment



Purpose: Our top priority is to rigorously evaluate policies, plans, and programs adopted by the City Council to ensure alignment with federal directives and compliance standards.

Goal: Drive measurable organizational impact through coordinated policy innovation and operational transformation to address socio-economic disparities and advance economic opportunities for all.



City of Dallas – Omnibus Resolution



Actions Taken

- Self-assessments performed by every department
- Multiple items flagged as needing modification or review
- Technical review by executive leadership
- Extensive legal review by City Attorney's Office
- On October 22, 2025, the Council Agenda will include an Omnibus Resolution that ensures continued federal compliance across departments.






BID Policy Stakeholder Engagement



- There was tailored engagement with small business stakeholders:
 - The City hosted multiple stakeholder engagement meetings with over 180 attendees from:
 - Prime & sub-contractors across all fields
 - Chambers of Commerce
 - Contractors Associations
 - Certification Agencies
 - Community/Outreach Agencies
- 60% of attendees believed the existing BID policy was "very to somewhat effective" in promoting M/WBEs







Housing & Urban Development (HUD) Consolidated Plan



- HUD Consolidated Plan is a comprehensive analysis and strategic plan:
 - Identifies community needs (see below)
 - Prioritizes needs
 - Details how needs will be addressed











- Includes four grants received by the City from HUD annually
 - ✓ Community Development Block Grant (CDBG)
 - ✓ Home Investment Partnership Programs (HOME)
 - ✓ Emergency Solutions Grants (ESG)
 - ✓ Housing Opportunities for Persons with AIDS (HOPWA)



HUD Consolidated Plan



Use of HUD Funds

- Improve quality of life for Dallas residents
- Enhance Economic Resilience
- Promote community development
- Support affordable housing



Actions Taken

- August 6, 2025 City Council adopted HUD Consolidated Plan Budget
- August 27, 2025 City Council approved initial consideration and a public hearing for a Substantial Amendment to amend the HUD 5-Year Consolidated Plan Budget
- Substantial Amendment will ensure alignment & compliance with federal directives authorizing the City Manager to make program and policy changes per Council's authorization.

 October 8, 2025-Public Hearing & Final Adoption of Substantial Amendment by City Council





Business Inclusion & Development (BID) Policy



Proposed BID Policy Redesign



- The City is transitioning from the 2008 BID Policy to the Developing Regional & Inclusive Vendor Enterprises (DRIVE) Policy, which will:
 - **Expand Inclusion** engage more small and local businesses to strengthen local participation
 - Promote Opportunity eliminate barriers and ensure an open, accessible procurement process
 - Build Business Capacity support sustainable business growth through mentorship and technical assistance
 - **Drive Economic Impact** grow small and local business participation to create jobs and boost the economy, and
 - Strengthen Regional Collaboration partner regionally through the Dallas Capacity Building Collaborative for cooperative purchasing, outreach, workforce development, and shared technical support.



Small & Local Business Landscape



 Of the 71,000 registered small businesses in Dallas County, 68% are micro businesses

 Less than 2% of small businesses in Dallas County have 250 or more employees, with 92% having less than 50 employees

BID Policy Suspension (June 26) – Effective Date of DRIVE Policy

Existing Contracts

- Reporting of all sub-contractor payments is required
- Proposed subcontractor and scope of work changes must be submitted and approved by the City per contract terms
- Identifying a strategy to bridge existing BID contract goals with new policy

Current Solicitations

- No participation goals or evaluation points are included
- Team Make-up forms required
- Encouraging prime-contractors to form teams that represent the communities we serve by including small and local businesses
- Identify a strategy to incorporate new policy

Future Solicitations

- Will include new policy goals and evaluation criteria
- Focus on Small and Local Business Enterprise participation

What It Is

- Adopted by City Council in August 2022
- City-wide plan
- Addressed racial and ethnic disparities in outcomes across Dallas
- Identified short, mid and long term Big, Audacious Goals (BAGs) and Department Progress Measures (DPMs).
- DPMs are specific actionable goals established to drive measurable improvements.

Task Completed

- REP & Equity Impact Assessment Tool temporarily ceased operationally beginning June 26, 2025 to present.
- Multi-departmental review of DPMs to ensure compliance with federal directives.

Tasks in Progress

- Move forward with compliant DPMs that are aligned with regulatory standards and community impact
- Transition to a new framework that can guide City plans & programs by measuring, reporting, and advancing opportunities for residents.





New Framework for Advancing Opportunities for Dallas Residents



Building on Drivers of Poverty Foundation



- From 2017, the City of Dallas partnered with community leaders and the Mayor's Task Force to create the *Drivers of Poverty* framework to confront the rise in poverty among Dallas residents.
- The Drivers of Poverty framework proved to be foundational in a systemic approach to understanding root causes of poverty and addressing disparities in outcomes across the city.
- These efforts helped the City of Dallas understand conditions that hold communities back.
- Today, we are moving to build on this important work to identifying pathways for opportunity.

- The Historic and Cultural Preservation Strategy discusses reducing racial disparities and preserving stories of certain marginalized communities
 - Updated language will shift focus from specific groups to all underinvestment in historic resources
- The South Dallas/Fair Park Area Plan promotes recommendations to be through an equitable lens
 - Updated language shifts will shift recommendations based on an equity lens to recommendations to help support small businesses and entrepreneurs and areas with a history of underinvestment on infrastructure.



What additional support would help compete more effectively?


