SUBJECT Upcoming Agenda Item #25-1592A: Dallas Accelerator Program (DAP) Service Contracts

On May 28, 2025, City Council will consider an item authorizing two service contracts to continue the administration of the Dallas Accelerator Program (DAP) for the Office of Procurement services: **(1)** Greater Dallas Hispanic Chamber of Commerce (GDHCC) in the amount of \$603,683, and **(2)** Dallas Fort Worth Minority Supplier Development Council, Inc. (DFWMSDC) in the amount of \$356,828, for a total amount of \$960,511.

Background

In June 2023, City Council awarded three service contracts for the launch and implementation of the DAP program, designed to accelerate the growth and sustainability of existing small businesses in Dallas. The original program operators were:

- Business & Community Lenders (BCL) of Texas
- Dallas Black Chamber of Commerce (DBCC)
- Greater Dallas Hispanic Chamber of Commerce (GDHCC)

The DAP Program has delivered measurable results:

- 60 Dallas-based small businesses completed the program
- Participants represented over 20 industries, including construction, media, education, insurance, landscaping, and auto services
- 21% of graduates reported a minimum 10% increase in business capacity
- Alexis Rueda, owner of J. Ruedas Trucking, LLC and a DAP graduate, was named 2025 Small Businessperson of the Year for the DFW Metroplex

Program Enhancements

The new contracts will expand and enhance DAP offerings with the following features:

- Streamlined, user-friendly online application process
- Customized curriculum
- Integration with the City's Mentor Protégé Program
- Additional program support services, including:
 - One-on-one business coaching
 - Peer-to-peer networking sessions
 - Capital pitch preparation and sessions
 - Ongoing performance evaluation and tracking
