SUBJECT 2017 Bond Program – 2nd Quarter Status Update (FY2023)

In November 2017, Dallas voters approved a \$1.05 Billion Bond Program, which included 10 propositions for the delivery of capital infrastructure projects to improve the quality of life for all residents across the City of Dallas. As of *March 31, 2023*, the City has committed \$810,101,960 or 77% of the bond authorization for the implementation of the 2017 approved bond projects. Please refer to Figure 1 (see page 2), which provides an overview of all bond funds committed in the implementation of the approved 2017 bond projects.

The 2017 Bond Program is comprised of 1,384 projects scheduled for delivery across various infrastructure disciplines. As of *March 31, 2022*, the City has awarded **1,322** or **96%** of the approved projects (refer to Figure 2 on Page 2 for project statuses).

As the 2017 Bond Program continues to move forward and nearing completion, the uncommitted available funds continue to be earmarked for the completion of the bond program approved projects.



SUBJECT 2024 Bond Program Development – Town Hall Meetings

Background

During the City Council briefing on March 1, 2023, the Office of Bond and Construction Management (BCM) provided updates on the development of the 2024 Bond Program. The 2024 Bond Program update included discussion of topics such as the proposed bond propositions, recommended funding amounts, project scoring, and town hall meetings to seek input from the community. As public input is a major component of the City of Dallas' development of the 2024 Bond Program, the purpose of this memorandum is to provide additional details on the upcoming 2024 Bond Program town hall meetings.

2024 Bond Program Development – Town Hall Meetings

Given the importance of community input in the development of the 2024 Bond Program, beginning in May 2023, BCM will contact each member Dallas City Council Member to schedule town hall meetings in each respective Council District. The purpose of the meetings is to provide the community an overview of the 2024 Capital Bond Program planning and development process and to ask for feedback on the community's infrastructure and capital needs as well as to solicit input on how funding should be prioritized. Community feedback from the town hall meetings will be shared with the Community Bond Task Force and Subcommittees as their work begins to review and recommend projects to be included in the 2024 Capital Bond Program.

SUBJECT City of Dallas Historic Tree Designation - May 10, 2023 City Council Agenda

The City of Dallas, through Article X, includes a historic tree provision that can be utilized on private and public property. This process includes permission from the property owner and affords additional protections for designated historic trees. On the May 10, 2023 City Council Agenda, you will be presented with one tree to approve under this provision of Article X. This tree, once designated, can only be removed by authorization of the City Council in a subsequent action item, or in the event of a critically dangerous public safety issue.

The following tree will be on your agenda: the West Dallas Gateway pecan tree.

As a reminder, a historic tree means "a tree, or grove of trees, that has been recognized by resolution of the city council as having cultural or historical significance". The owner of the property and tree must be in agreement and authorize in writing the requested designation since this will be filed at the County as part of Deed Restrictions.

The nomination packet will include the following:

- cultural or historical significance to the community
- tree qualifications must be stated on the application or supplemental documents.
- located on an historic site or is adjacent to the historic site
- rare characteristic for its unique large size, age, or species for the region or state
- established in community recognition, or in memorial, to a person, place, or event
- community landmark and recognized as a significant feature of the site
- complementary information may be provided to address the significant size and age of the tree, the uniqueness of the species, its importance in arboriculture, and other noted relevant history

A complete application will be reviewed by the city arborist for its condition, standards of maintenance, and the growing environment. SUBJECT Dallas Police Department Resources and City of Dallas Trails

On April 17th, a Pedestrian and Trail Safety briefing was presented to the Quality of Life, Arts, and Culture Committee by the Park and Recreation Department, Dallas Police Department (DPD), and the Dallas Marshalls. During this briefing, Chairman Bazaldua requested an assessment of DPD resources used to patrol the following trails: White Rock, AT&T Trinity Trail, Katy, and Santa Fe.

This assessment focused only on the number of cumulative "Overtime Hours" for the aforementioned trails as on-duty hours varied on many factors to include but not limited to call load and other-directed enforcement activities.

CY 2022 – 2951 Patrol Hours YTD 2023 – 248 Patrol Hours

Additionally, a request was made in regard to Slide 19 and updated metrics for Murders. As of this writing, zero murders have been reported on any trail within the City of Dallas.

Follow-Up Responses to Questions from March 20, 2023, TRNI Council Committee Meeting – Public Works Smart City Initiatives Briefing

Background

On March 20, 2023, the Department of Public Works briefed the Transportation and Infrastructure Committee (TRNI) on various completed and ongoing smart city initiatives. During the March 2023 briefing, some questions were asked by the TRNI Committee that required additional staff research and follow-up. As staff has completed the research of the outstanding TRNI Committee questions, the purpose of this memorandum is to provide the requested follow-up.

Follow-Up Information from TRNI Committee Questions and Requested Information

- 1. Provide performance metrics (number of connections made and usage hours) for each completed Wi-Fi project: (Response) Please see attachment.
- 2. What are the ongoing hardware operational & maintenance (0&M) costs of the various networks?

(Response) The table below describes the annual recurring O&M costs of circuits, bandwidth, utilization, and support:

3. Singing Hills Recreation Center - Provide the exact pole location connected by fiber to the recreation center that supports residential Wi-Fi to the community, as residents have reported connectivity issues. Homes could be up to 1200' from the broadband network pole. What is the Wi-Fi range?

(Response) Wi-Fi range is up to 200 ft from access point, the attached document depicts locations of access points as well as estimated vs. actual coverage objectives and pole locations. Wi-Fi range beyond the City facility cannot be guaranteed and is an estimate based upon the capability of the Wireless Access Point devices installed and impacted by several factors that include weather, topography, obstructions, and construction of buildings, to name a few. Availability of data is dependent upon the configuration of the network devices respectively.

4. In the next five years, what is the projected demand for Electric Vehicle Charging Stations in Dallas?

(Response) The Texas Department of Transportation (TxDOT) projected electric vehicle usage of approximately 1M vehicles in Texas by 2030; this estimate was based on ERCOT's long-term system assessment scenario to evaluate grid capacity and planning for long range demands of energy use, but clearly maintains that it was merely a possible scenario, not a projection. However, a North Central Texas Council of Governments (NCTCOG) representative stated that the estimation was too low causing electric vehicle infrastructure demand projections to no longer be accurate; this region alone has already reached or exceeded predicted usage and is approximately 7 years ahead of the unofficial model used to forecast demand. NCTCOG is working to investigate if a regional goal should be set and investigate usage ratios to determine where groups would recharge vehicles (homes or public-facing stations).

SUBJECT Good Jobs Good Airports Act

During a meeting of the City Council Transportation and Infrastructure Committee on Monday, April 17, staff was asked to provide additional information regarding the Good Jobs Good Airports Act Bill (HR 1449/S 753) and resolution. This bill addresses pay, benefits, and labor standards for certain airport service workers. Airport service workers include security officers, food service workers, cleaning staff, ticketing agents, and retail service workers. Specifically, the bill establishes a minimum wage and benefit standard for such airport service at large, medium, and small hub airports.

The bill would require small, medium, and large hub commercial service airport owners and operators to obtain from each entity that employs service workers certification that the requisite wages and fringe benefits have been paid, and submit a compliance report annually to the Secretary of Transportation. The bill would also require the same certification by airports as a condition of collecting a Passenger Facility Charge, receiving a discretionary Airport Improvement Program Grant, receiving an Airport Infrastructure Grant, and receiving an Airport Terminal Grant. While the bill's intent appears favorable, the language currently states that the airport operators would be responsible for entities that are not in compliance, potentially causing cities to lose airport improvement funding as well as ineligibility for airport terminal and infrastructure grants.

We are working with our federal legislative team, the Department of Aviation, and DFW Airport, on actions that may be considered locally.

Below are questions asked during the committee meeting and corresponding answers. Please note we will include this information in a briefing for your next committee meeting.

- What is the current federal wage/current minimum wage for other states? The current federal minimum wage is \$7.25 per hour. Employers to which the Fair Labor Standards Act (FLSA) applies must adhere to the federal minimum wage requirement. States may set their own minimum wage requirements that exceed the federal rate. State minimum wages are available here. Currently only California, Washington, and the District of Columbia have rates higher than \$15.00 an hour.
- Does this bill also include Dallas Executive Airport? No, the bill would not apply to Dallas
 Executive Airport. It only applies to small hub airports, medium hub airports, and large
 hubs airports. Under federal aviation law, those terms describe commercial service
 airports. Dallas Executive Airport is a general aviation airport. (Dallas Love Field is a
 medium hub commercial service airport and DFW is a large hub commercial service
 airport, so the bill would apply to both.)

Good Jobs Good Airports Act

- At the State level are there any bills concerning minimum wage? Yes there are several bills at the state level regarding minimum wage.
 - SB 582 (Eckhardt): Relating to authorization for a county or municipality to establish a local minimum wage.
 - HB 193 (Ortega): Relating to authorization for a county or municipality to establish a local minimum wage.
 - HB 1126 (Martinez Fischer): Relating to the minimum wage.
 - o HB 1919 (Goodwin): Relating to the minimum wage.
 - o HB 737 (Walle): Relating to the minimum wage.
 - HB 169 (Reynolds): Relating to the minimum wage.
- What is the timeline for the amending of the resolution? Position on a resolution considered by the City Council is subject to City Council action. The bill is not expected to move in the House. If it moves in the Senate, it may likely be as part of the broader FAA reauthorization bill. The Senate Commerce Committee is expected to begin consideration of the FAA reauthorization bill later this spring or summer.
- Is the bill the final draft from Washington? The bill has been introduced in the House (HR 1499) and the Senate (S 753). No bill is final until it is sent to the President, meaning it can be amended at most steps of the legislative process. For now, all we have are the bills as introduced. They have been referred to the House Transportation & Infrastructure Committee and the Senate Commerce Committee. Neither committee has taken any action on them. If the bill moves, it will be in the Senate, most likely as part of a broader FAA reauthorization bill. The House and Senate bills are identical. They would amend the statute governing the airport improvement program (49 USC 47107) to make the awarding of Airport Improvement Grants conditional on the airport owner providing written assurances that "covered service workers" are paid at least \$15 per hour and receive fringe benefits that are in line with those prevailing in local collective bargaining agreements (as outlined in 41 USC 6703).

SUBJECT Planned Citywide Internet and Network Maintenance Outage

On Tuesday, May 9, the City's 24/7 call centers (311 and Aviation), Internet, City Network external traffic, and websites including DallasCityHall.com and DallasPolice.net, will be unavailable from approximately 2:00 a.m. to 3:00 a.m. due to a planned system outage. The Enterprise Network team will upgrade the operating system of core switches to resolve a known issue that is impacting City security services, as well as update configurations related to device failover to mitigate the risk of unplanned outages. Due to the nature of the upgrade process, it is not possible to perform a non-disruptive upgrade to the devices, necessitating a short outage. Upon completion, future upgrades will not require outages during these maintenance activities. During the maintenance window, network connectivity to external servers, application sites, and services will be unreachable until connectivity is re-established.

*Public Safety 911 and CAD system will be available, however, communication to and from mobile devices will be impacted.

During the scheduled outage, residents will experience a busy signal when calling the 311 or Aviation call center. Residents experiencing urgent 311 requests related to water main breaks or pipe breaks will be directed to call 911 during the outage. Alerts will be placed on the OurDallas mobile app, the City's website, and social media platforms notifying 311 users of the scheduled outage. Phone calls to the 311 or Aviation call center will be restored after all required system testing is complete.

Internal communications will be sent out a week before, a day before, and the day of the maintenance to all departments.

Status Update on Cypress Creek at Forest Lane, a Potential Mixed-Income Housing Development to be Located at 11520 North Central Expressway

Background

The purpose of this memorandum is to provide a status update on Cypress Creek at Forest Lane (Development). On February 27, 2023, the Housing and Homelessness Solutions Committee (HHSC) was briefed on the Development proposed as a 189-unit mixed-income multifamily community that will reserve 7% of the units for residents earning less than 80% Area Median Income (AMI), 22% of the units for residents earning less than 70% AMI, 25% of the units for residents earning less than 30% AMI, and 46% of the units will be non-income restricted. The HHSC was also informed that the project site is deed restricted with private restrictive covenants that do not allow for multifamily development. Staff supports the proposed multifamily project to carry out the City's affordable housing public purpose. However, for the City to carry out its affordable housing public purpose in an identified high opportunity area of the City, the City needs to acquire the site and maintain ownership for the duration of the project so that the restrictive covenants would not be enforceable. The plan as presented to the HHSC in February 2023 to move forward with this Development contemplated that the City would acquire the site (such acquisition being funded by the developer, Sycamore Strategies) and then the City would convey the land to the Dallas Public Facility Corporation (DPFC). The City's conveyance to the DPFC would be pursuant to a state law exception (Texas Local Government Code 272.001(g)) enabling the City to convey public property to an entity for development of low to moderate income housing. The DPFC would then enter into a long-term lease with the Developer to construct and manage the Development.

Issue

This plan was presented for consideration and approval to the DPFC Board of Directors (Board) on March 28, 2023. The Board conditionally approved a memorandum of understanding (MOU) that outlined the City's conveyance of the project site to the DPFC and the subsequent lease to the Developer. However, the conditional approval of the Board is tantamount to a denial because the conditions were unacceptable to the City and thus the project cannot move forward under the proposed structure.

Staff Alternative Recommendation

An alternative approach recommended for City Council consideration is for the City to enter into a ground lease agreement directly with the Developer to finance, construct, and manage the Development. This alternative has no DFPC participation, but will include a

> Developer obligation to indemnify the City for any potential litigation expenses and damages for the duration of the project ground lease term. The City will require the standard performance and payment bond requirements for a transaction of this kind.

> Without the City's participation in this acquisition and ground lease development structure, this mixed-income affordable housing development will not move forward to serve the City's affordable housing public purpose. City Council already provided its support for the placement of a 9% competitive tax credit development at this site via City Council Resolution 21-0378. The Developer's application for a resolution of support met all threshold requirements of the City's Low Income Housing Tax Credit Policy and qualified for a recommendation by the Department of Housing & Neighborhood Revitalization as it is a priority housing needs development (located in a census tract with less than 20% poverty). This resolution of support was approved by City Council on February 24, 2021. The project was subsequently awarded 9% housing tax credits by the Texas Department of Housing & Community Affairs (TDHCA).

> Staff will work in collaboration with the City Attorney's Office to finalize ground lease terms for City Council consideration and approval on the May 10, 2023 Council Agenda.

Update on Federal Infrastructure Investment and Jobs Act and Inflation Reduction Act Funding

The Office of Government Affairs continues to work with partner departments to identify potential projects and submit competitive grant applications for programs included in the Infrastructure Investment and Jobs Act of 2021, also commonly referred to as the Bipartisan Infrastructure Law (IIJA or BIL). BIL is a five-year authorization of new and existing grant programs aimed at improving the nation's core infrastructure needs.

As we head into Year 2 of federal implementation of BIL, City staff will update the Opportunity Projects list based on lessons learned and feedback from federal agencies. The Opportunity Projects list identifies projects that are likely to be a good fit for BIL grant programs. It is not a ranked or prioritized list, and is focused on programs where the City is likely to be an eligible applicant. The current list is attached. Please send any requested changes or additional projects to Dina Colarossi at dallas.gov.

Infrastructure Investment and Jobs Act Activities

To date, the City has taken the following actions for BIL funding since the last update to Council on December 23, 2022:

Grant Applications Awarded

- Affordable Connectivity Program Outreach Grant Program \$700,000
 - This grant will provide funding for a media campaign and outreach events to increase enrollment in the Affordable Connectivity Program, which provides subsidy for broadband internet service for eligible households. Dallas County, DISD, and the Dallas Housing Authority are partners, and will be subrecipients on this grant. It is expected to come to Council for approval within 30 days of receiving the grant contract from the FCC, currently projected for an agenda date in May.
- Thriving Communities Technical Assistance Program
 - The City was selected as a finalist for planning and community outreach assistance in the Westmoreland Heights/Lake West neighborhood to integrate transportation, housing, and economic development initiatives, however was ultimately not selected to receive the assistance.

Grant Applications Submitted

- RAISE
 - Submitted an application for planning and design for 5 Mile Creek Trail, in partnership with the Trust for Public Land

- Submitted a planning application for a City-wide Freight Mobility Study
- Partnered with NCTCOG on their application for continued infrastructure needs for the Southern Gateway Park

Other Pending Applications

- Brownfields
 - An Assessment grant and a Revolving Loan Fund grant to provide environmental assessments and cleanup assistance for eligible projects in the Fair Park/South Dallas area
- Railroad Crossing Elimination Program
 - Westmoreland Road Grade Separation to eliminate at-grade crossings with Union Pacific (UP) and DGNO tracks
 - Skyline Bridge Grade Crossing Elimination to provide an alternate to an atgrade crossing for LOOP Trail users in partnership with the Circuit Trail Conservancy
 - A partnership with NCTCOG on their application to eliminate the at-grade crossing on Prairie Creek near the UP Intermodal Facility
- WaterSMART Water and Energy Efficiency Grants
 - o Dallas Water Utilities implementation of Advanced Metering Infrastructure
- Middle Mile Broadband Infrastructure
 - A partnership with Crown Castle on their application to build out middle mile broadband infrastructure to connect underserved communities and anchor institutions

Award announcements for all programs listed above are expected in Spring 2023.

Planned Grant Applications

- Energy Efficiency and Conservation Block Grants due Summer 2023
 - Funds planning and implementation for projects that increase energy efficiency and conservation. The City of Dallas is expected to receive \$1.13M under this program, and staff has convened a working group to identify the best uses for this one-time funding.
- Charging and Fueling Infrastructure Discretionary Grant due May 30
 - Funds charging infrastructure for electric and other alternative fuel vehicles with a focus on historically disadvantaged communities. The City will join a regional application led by NCTCOG.
- TxDOT Transportation Alternatives Program due June 5
 - Planning for improved multi-modal connectivity in the Esperanza Neighborhood
 - Planning for improved pedestrian and bike connectivity for the area surrounding I-635/Skillman bridge
 - Construction of 1.2 miles of shared-use path on the 5 Mile Creek Trail from Westmoreland Rd. to S. Hampton Rd.

Update on City Activities for Federal Infrastructure Investment and Jobs Act and Inflation Reduction Act Funding

- Safe Streets and Roads for All (SS4A) due July 10
 - Resubmission of NCTCOG's FY22 application for the Martin Luther King, Jr./Cedar Crest Blvd Complete Street and Safety Upgrades project. The City will be the lead applicant for the FY23 application.

Inflation Reduction Act Activities

In addition to BIL, the Inflation Reduction Act of 2022 (IRA) also authorized several grant programs and tax credits the City can access to meet our climate and energy efficiency goals. Most programs funded by IRA are still in the planning stages, and Office of Government Affairs staff is actively monitoring for opportunities to comment on programs as they are being developed, and for information and guidance for grants and tax credits as they are released.

To date, the City has taken the following actions for IRA funding:

Planned Grant Applications

- Climate Pollution Reduction Grants due Spring 2023
 - Funds the development of a plan to cover the DFW Metropolitan Statistical Area (MSA). NCTCOG will be the lead applicant for the MSA, and the City will partner on the application and the development of the plan.
- USDA Forest Service Urban & Community Forestry due June 1
 - Funds an array of forestry projects, including planning, workforce development, and enhancements to tree canopy and urban forests
