Consideration of Legislative Priorities for the 119th Congress and 89th Texas Legislature Update

On Wednesday, September 18, the Dallas City Council received a briefing by the Office of Government Affairs in collaboration with the City Attorney's Office regarding consideration of the city's legislative priorities for the 119th Congress and 89th Texas Legislature.

City Council received an overview of the legislative program development process, communication and stakeholder engagement, legislative environment compatibility, all priorities submitted, along with staff recommendations, that began in Fall 2023. At that time, the Office of Government Affairs sent out a request to all City Council Members, committees, city staff, and external stakeholders to submit their proposed legislative priorities for City Council's consideration. All submitted priorities were vetted through various city departments, eight standing committees, the Ad Hoc Committee on Legislative Affairs, and City Council.

At the September 18, 2024, briefing, City Council directed staff to develop a hybrid program that encompasses the entirety of the City Council's legislative goals, considering various factors. Attached please find the draft hybrid state legislative program incorporating the City Council's feedback. The City Council is scheduled to consider taking action on the draft state and federal legislative programs on Wednesday, September 25 (Agenda Items #40-41).




