Dallas City Code Chapter 2-11.2 Code Amendment - Administrative Real Property Acquisitions

At your upcoming City Council meeting on November 13, 2024, you will consider an action item to amend Chapter 2-11.2 of the Dallas City Code to increase the threshold of administrative real property acquisitions from \$10,000 to \$100,000. On September 23, 2024, staff briefed the Government Performance and Financial Management Committee on the proposed amendment as a process improvement initiative resulting in administrative and operational efficiency.

Currently the city code stipulates a maximum threshold for administrative real property acquisitions at \$10,000. This limit has been in place for more than 30 years without any adjustments to account for inflation or evolving needs of our City. In contrast, the City's current contracting policy allows contracts of up to \$100,000 to be processed administratively without requiring additional extensive organizational procedures.

Staff is recommending an amendment to Chapter 2-11.2 to increase the threshold to \$100,000. This amendment will, 1) align acquisition practices with existing contracting thresholds; 2) streamline processes and reduce unnecessary delays; 3) enhance market responsiveness, by allowing timelier transactions and fostering better relationships with the community; and 4) expedite certain acquisition projects to allow departments to move forward swiftly with construction and/or development needs benefiting the intended public project.

This amendment is a necessary step to modernize our administrative acquisition processes, ensuring they are efficient, cost-effective, and responsive to the needs of our City.
