Most recently, as Senior Vice President and CIO for Abt Global, he directed global IT, cybersecurity, and digital strategy across operations in more than 30 countries resulting in a reduction of IT costs by nearly half while improving integration, performance, and scalability.

His career also includes key leadership roles with Oracle Corporation, PMMC, and Sprint Nextel, where he successfully managed post-merger integrations, led enterprise-wide transformations, and implemented technology solutions that delivered millions in cost savings and operational efficiencies.

At the City of Dallas, Jeffrey will lead key initiatives to assess, prioritize, and modernize outdated systems, addressing technical debt while improving security and sustainability. He will also integrate artificial intelligence into operations, enhancing efficiency and data-driven decision-making while ensuring ethical AI use and maintaining public trust.

Jeffrey holds a Bachelor of Science in Mechanical Engineering from the Massachusetts Institute of Technology (MIT) and a Master of Business Administration from the University of Virginia's Darden School of Business.

He has been recognized with numerous honors, including *Public Sector CIO of the Year*, and remains an active leader in the technology community. He currently serves as a member of the Society for Information Management and as Chairman and Dean's Advisory Board Member for the UNC Charlotte College of Computing.
