SUBJECT **FY26 Federal Appropriations and Community Project Funding Update**

On February 3, 2026, President Donald Trump [signed](#) a roughly \$1.2 trillion spending package funding major federal departments, including Defense, Transportation and Housing, Education and Health, Financial Services, National Security, and Homeland Security.

The legislation completes funding for 11 of the 12 annual appropriations bills required to operate the federal government in FY 2026. The Homeland Security bill will be funded through a short-term continuing resolution extending through February 13 while Congress continues discussions on a full-year funding agreement which includes proposed changes to immigration enforcement policy.

At the same time, congressional appropriators are expected to begin early planning for FY 2027 ahead of the September 30, 2026, funding deadline, as the 2026 midterm elections may limit legislative activity later in the year.

## **Community Project Funding Requests**

FY 2026 Community Project Funding requests (earmarks) were signed into law as part of the appropriations bills. The City of Dallas will receive funding for 17 projects totaling **\$14,975,000**. This funding represents the largest total of Community Project Funding the City has received since the federal process was revamped in 2021.

In addition, we have included a list of partner projects in blue which impact the Dallas area but are administered by external entities.

**Transportation-HUD Bill Highlights**

In addition to Community Project Funding, the Transportation-HUD appropriations bill includes several City of Dallas legislative priorities. Funding levels for the Community Development Block Grant and the HOME Investment Partnerships Program remained unchanged from the prior fiscal year, with Community Development Block Grants funded at \$3.3 billion and the HOME program funded at \$1.25 billion.

The bill also includes \$100.25 million in supplemental transit funding for World Cup host cities. These funds are expected to be allocated to transit agencies using a formula based on host stadium capacity (70 percent) and the number of matches hosted (30 percent).

**Next Steps**


As the City receives funding, departments will coordinate with the appropriate federal agencies to draw down the funds. This process typically takes one to two years, and City Council action will be required to formally accept the funds.

We encourage city leadership to thank members of the City's congressional delegation and their staff for their leadership and continued support in securing Community Project Funding for the City of Dallas.
