

## LEGAL DESCRIPTION

BEING a tract of land out of the THOMAS LAGOW SURVEY, ABSTRACT 759, located in City Block 7955, in the City of Dallas, Dallas County, Texas and being part of a called 94.3 Acre tract of land described in deed from Jaunita Lesley to Wayne Yarbrough recorded November 6, 1990 in Volume 90217, Page 0547 of the Deed Records of Dallas County, Texas, said tract also being part of the old City of Dallas Land Fill site and being more particularly described by metes and bounds

BEGINNING at a point in the Southwesterly right-of-way line of Second Avenue (a 240' ROW), said point being South 44°06'50" East a distance of 198.08 feet from the Southeasterly Right-of-Way line of the Southern Pacific Railroad;

THENCE South 44°06'50" East, with said Southwesterly right-of-way line of Second fivenue a distance of 50.02 feet to a point for a corner;

THENCE South 44°08'42" West, departing said Southwesterly right-of-way line of Second Avenue a distance of 140.75 feet to an angle point;

THENCE South 27°03'00" West, a distance of 59.45 feet to an angle point;

THENCE South 40°22'00" East, a distance of 51.10 feet to an angle point;

THENCE South 03°10'00" East, a distance of 111.00 feet to an angle point;

THENCE South 24°37'00" East, a distance of 203.00 feet to an angle point in the "High Bank" fill line of said old City Land Fill Site:

North 44\*31'32" West, 651.25 feet to a point for a corner in the aforementioned Southeasterly right-of-way of Southern Pacific Railroad (120 feet off center line at this point);
