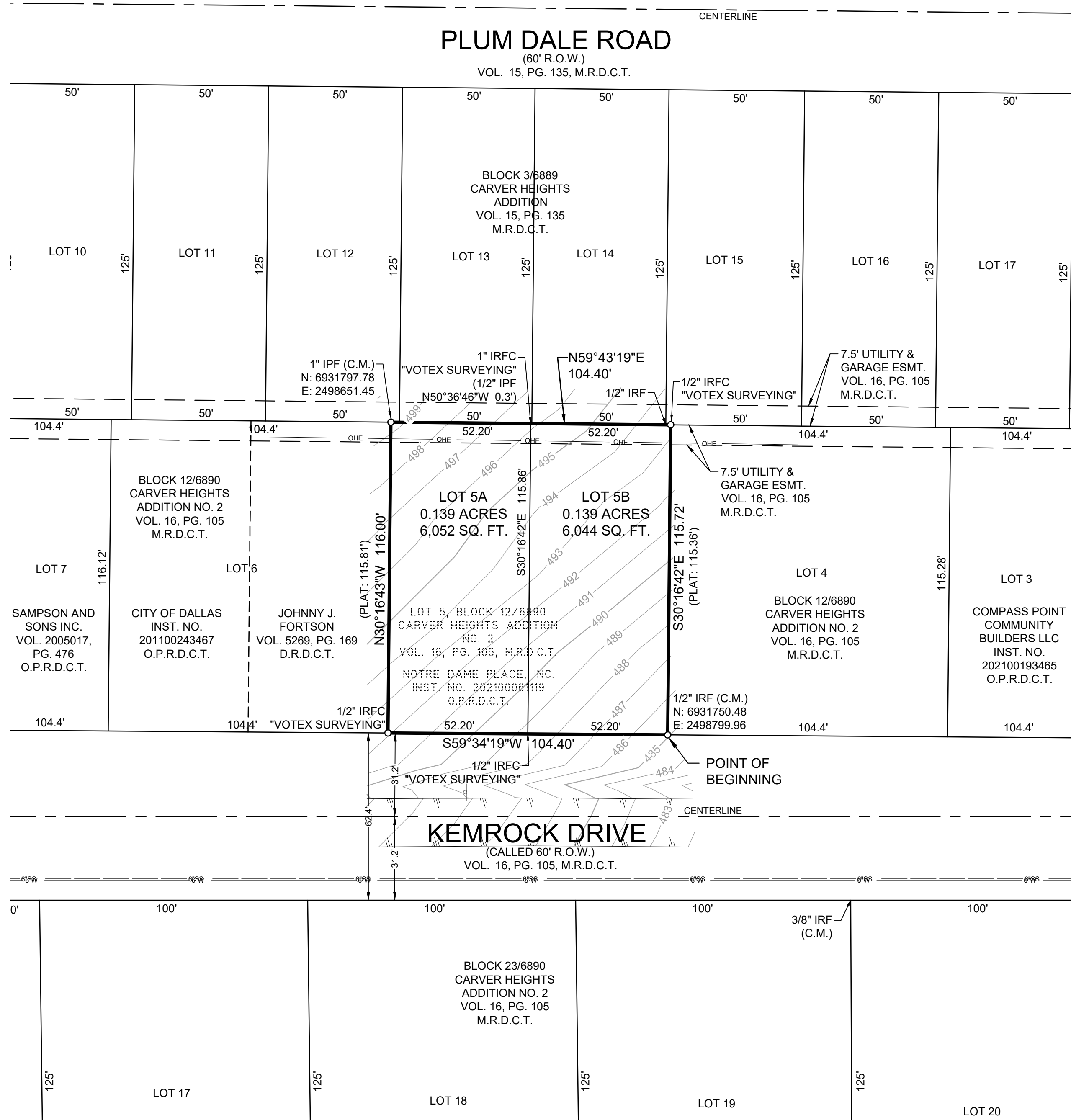
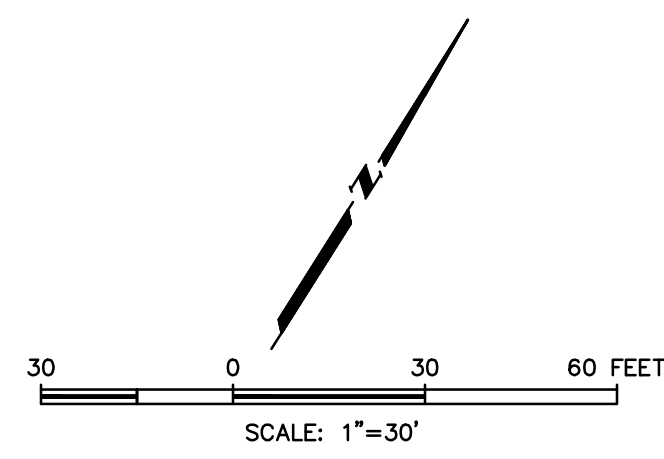


LOCATION MAP

WHEREAS NOTRE DAME PLACE, INC. is the owner of that tract of land situated in the Lewis Horst Survey, Abstract No. 556, City of Dallas, Dallas County, Texas, and being all of Lot 5, Block 12/6890 of Carver Heights Addition No. 2, an addition to the City of Dallas, Dallas County, Texas according to the plat thereof recorded in Volume 16, Page 105, Map Records, Dallas County, Texas; same being all of that tract of land conveyed to Notre Dame Place, Inc. by Deed without Warranty recorded in Instrument No. 2021000061119, Official Public Records, Dallas County, Texas, and being more particularly described as follows:

**BEGINNING** at a 1/2-inch iron rod found for corner in the northwest right-of-way line of Kemrock Drive (a 60-foot wide right-of-way) at the east corner of said Lot 5;

**THENCE** S 59°34'19" W, with said northwest right-of-way line of Kemrock Drive, a distance of 104.40 feet to a 1/2-inch iron rod with yellow plastic cap stamped "VOTEX SURVEYING" found at the south corner of said Lot 5;

**THENCE** N 30°16'43" W, departing said northwest right-of-way line, a distance of 116.00 feet to a 1-inch iron pipe found for corner in the southeast line of Block 3/6889, Carver Heights Addition, an addition to the City of Dallas, Dallas County, Texas according to the plat thereof recorded in Volume 15, Page 135, Map Records, Dallas County, Texas at the west corner of said Lot 5;

**THENCE** N 59°43'19" E, with said southeast line of Block 3/6889, a distance of 104.40 feet to a 1/2-inch iron rod with yellow plastic cap stamped "VOTEX SURVEYING" found at the north corner of said Lot 5;

**THENCE** S 30°16'42" E, departing said southeast line of Block 3/6889, a distance of 115.72 feet to the **POINT OF BEGINNING** and containing 12,096 square feet of 0.278 acres of land, more or less.

OWNER'S DEDICATION

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That Notre Dame Place, Inc., acting by and through their duly authorized agents, do hereby adopt this plat, designating the herein described property as **KEMROCK NO. 1 ADDITION**, an addition to the City of Dallas, Dallas County, Texas, and do hereby dedicate, in fee simple, to the public use forever any streets, alleys, and floodway management areas shown thereon. The easements shown thereon are hereby reserved for the purposes indicated. The utility and fire lane easements shall be open to the public, fire and police units, garbage and rubbish collection agencies, and all public and private utilities for each particular use. The maintenance of paving on the utility and fire lane easements is the responsibility of the property owner. No buildings, fences, trees, shrubs, or other improvements or growths shall be constructed, reconstructed, or placed upon, over or across the easements as shown. Said easements being hereby reserved for the mutual use and accommodation of all public utilities using or desiring to use same. All, and any public utility shall have the right to remove and keep removed all or parts of any building, fences, trees, shrubs, or other improvements or growths which in any way may endanger or interfere with the construction, maintenance or efficiency of its respective system on the easements, and all public utilities shall at all times have the full right of ingress and egress to or from the said easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and adding to or removing all or parts of its respective systems without the necessity at any time of procuring the permission of anyone. (Any public utility shall have the right of ingress and egress to private property for the purpose of reading meters and any maintenance or service required or ordinarily performed by that utility).

Water main and wastewater easements shall also include additional area of working space for construction and maintenance of the systems. Additional easement area is also conveyed for installation and maintenance of manholes, cleanouts, fire hydrants, water services and wastewater services from the main to the curb or pavement line, and description of such additional easements herein granted shall be determined by their location as installed.
