



Whereas, Gustavo Gonzalez is the owner of a tract of land situated in the Enoch Horton Survey, Abstract No. 613, City of Dallas, Dallas County, Texas as conveyed by deed recorded in Volume 98093, Page 874, Deed Records, Dallas County, Texas and being all of Lots 1, 2 and 3, Block 20/8342 of Arcadia Park Addition, an addition to the City of Dallas, Texas, according to the plat thereof recorded in Volume 1, Page 377, Map Records, Dallas County, Texas, and being more particularly described as follows:

OWNER'S CERTIFICATE

Beginning at a 1" bolt found at the intersection of the southerly right—of—way line of W. Jefferson Boulevard (170' R.O.W.) and the west right—of—way line of N. Tatum Avenue (50' R.O.W.) and being the northeast corner of said Lot 1;

Thence, South 00°46'37" East, along the west right—of—way line of N. Tatum Avenue (50' R.O.W.) and the east lines of said Lots 1, 2 and 3, a distance of 141.00 feet to a 1/2" iron pin set with yellow cap stamped "CCG INC RPLS 5129" for the southeast corner of said Lot 3 and the northeast corner of Lot 4 of said Block 20/8342;

Thence, South 89°13'23" West, along the south line of said Lot 3 and the north line of said Lot 4, a distance of 175.00 feet to a 1/2" iron pin set with yellow cap stamped "CCG INC RPLS 5129" for the southwest corner of said Lot 3, the northwest corner of said Lot 4, the northeast corner of Lot 38 of said Block 20/8342 and the southeast corner of Lot 39 of said Block 20/8342;

Thence, North 00°46'37" West, along the west lines of said Lots 1, 2 and 3, the east line of said Lot 39, the east line of Lot 39A, Block 20/8342 of Bernardino Ortega Gonzales Addition, an addition to the City of Dallas, Texas, according to the plat thereof recorded in Instrument No. 201000072666, Official Public Records, Dallas County, Texas, the east line of Lots 41 and 42 of said Block 20/8342, a distance of 197.00 feet to a 1/2" iron pin set with yellow cap stamped "CCG INC RPLS 5129" on the southerly right—of—way line of W. Jefferson Boulevard (170' R.O.W.) and for the northwest corner of said Lot 1 and the northeast corner of said Lot 42, said point being in a curve to the right having a central angle of 01°23'45", a radius of 7542.51 feet and a chord bearing of South 73°01'56" East, a distance of 183.74 feet;

Thence, southeasterly, along the southerly right—of—way line of W. Jefferson Boulevard (170' R.O.W.) the northeasterly line of said Lot 1 and said curve to the right, an arc distance of 183.75 feet to the Point of Beginning and containing 29,644 square feet or 0.681 acres of land.

OWNER'S DEDICATION

NOW THEREFORE. KNOW ALL MEN BY THESE PRESENTS:

That, Gustavo Gonzalez, does hereby adopt this plat, designating the herein described property as ARCADIA PARK ADDITION LOT 1A, BLOCK 20, an addition to the City of Dallas, Dallas County, Texas, and does hereby dedicate, in fee simple, to the public use forever any streets, alleys, and floodway management areas shown thereon. The easements shown thereon are hereby reserved for the purposes indicated. The utility and fire lane easements shall be open to the public, fire and police units, garbage and rubbish collection agencies, and all public and private utilities for each particular use. The maintenance of paving on the utility and fire lane easements is the responsibility of the property owner. No buildings, fences, trees, shrubs, or other improvements or growths shall be constructed, reconstructed or placed upon, over or across the easements as shown. Said easements being hereby reserved for the mutual use and accommodation of all public utilities using or desiring to use same. All, and any public utility shall have the right to remove and keep removed all or parts of any building, fences, trees, shrubs, or other improvements or growths which in any way may endanger or interfere with the construction, maintenance or efficiency of its respective system on the easements, and all public utilities shall at all times have the full right of ingress and egress to or from the said easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and adding to or removing all or parts of its respective systems without the necessity at any time of procuring the permission of anyone. (Any public utility shall have the right of ingress and egress to private property for the purpose of reading meters and any maintenance or service required or ordinarily performed by that utility).

Water main and wastewater easements shall also include additional area of working space for construction and maintenance of the systems. Additional easement area is also conveyed for installation and maintenance of manholes, cleanouts, fire hydrants, water services and wastewater services from the main to the curb or pavement line, and description of such additional easements herein granted shall be determined by their location as installed.
