NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Pandi1 LLC, acting by and through its duly authorized agent, Pandian Kumar, does hereby adopt this plat, designating the herein described property as **WILHURT ADDITION**, an addition to the City of Dallas, Dallas County, Texas, and do hereby dedicate, in fee simple, to the public use forever any streets, alleys, and floodway management areas shown thereon.
