B. Day of Dignity

Ms. Jones reported that the Day of Dignity event that took place on Saturday, September 24, 2016 from 10am-1pm was again a very big success. This is a great partnership with the Islamic community. The attendance for the event was over 3,500 people and we were able to service and pay TXU bills for 313 customers. It was truly a great event! Ms. Wicks was also in attendance and did a live social media broadcast for the event.

C. Harambee Festival

Ms. Jones reported that sue to the lack of funds the event has been scaled down for 2016. It will take place on the grassy knoll area in the middle of the center. With the help of Councilwoman Young, community/steering committee members, and the center the event will take place. The center will make sure that the children are feed and that they receive treat bags for the event. We will continue to make sure that the event is a good event.

D. 35th Annual MLK Celebration

Mr. Rogers reported that we are still working on the details surrounding the 35th Annual Dr. Martin Luther King, Jr. Celebration Weekend. Our speaker is Dr. Walter Kimbrough.
