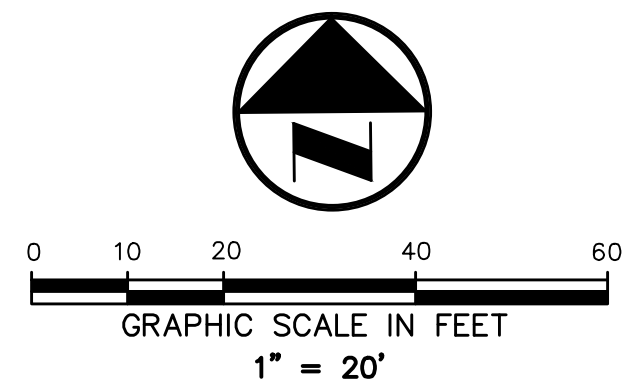
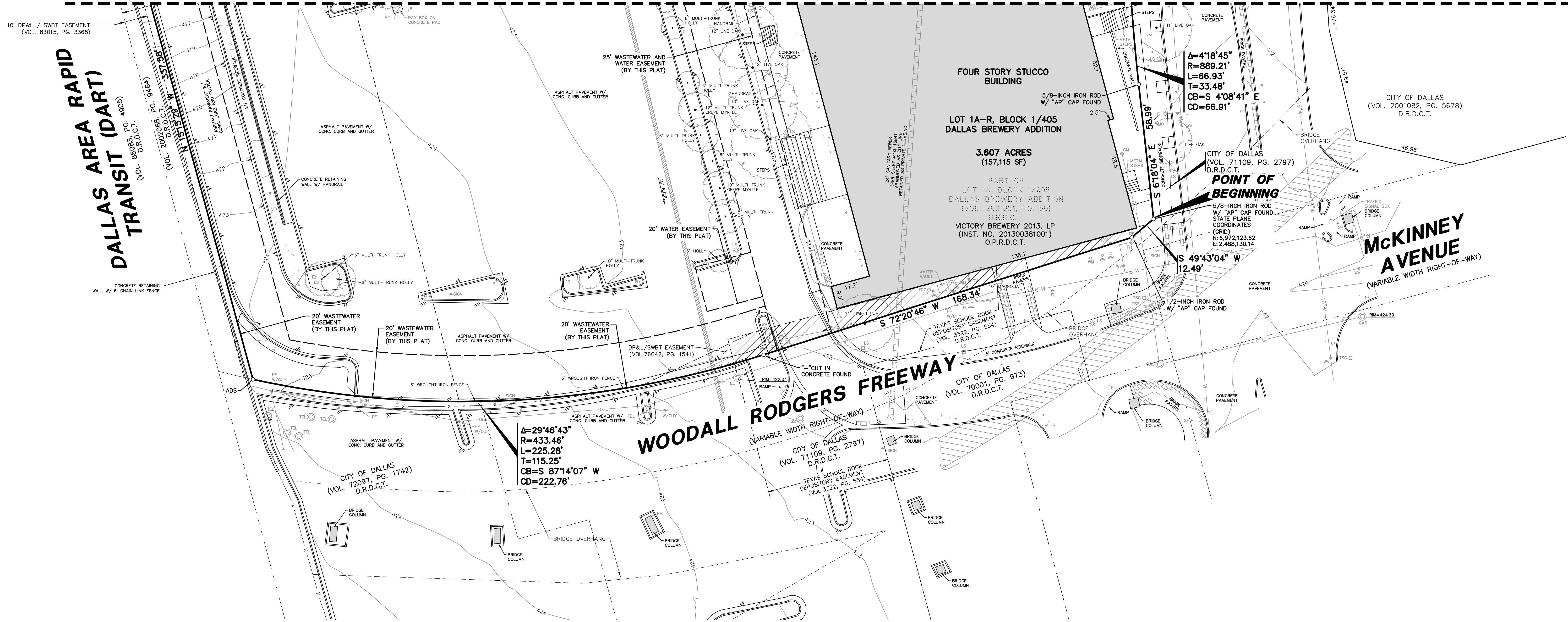


VICINITY MAP
