4. **Dallas Police Department (BlueTeam – Response to Resistance Reporting)**

**Presenter:** Sergeant Kris Kelly, Dallas Police Department

BlueTeam Purpose:

- BlueTeam is a web based application allowing front line personnel to enter information quickly into a review process
- BlueTeam allows officers to stay in field while entering required information
- BlueTeam has been used since 2013 to capture data on officer response to resistance (use of force) incidents
- BlueTeam is critical in capturing the data required for the White House Open Data Initiative
