AFFIDAVIT OF DONNA ROGERS

Before me, the undersigned notary personally appeared Donna Rogers, who being duly sworn did depose as follows:

- My name is Donna Rogers. I am over the age of twenty-one (21), of sound mind and body, and competent to make this affidavit. The statements set forth in this affidavit are true and correct and based upon my personal knowledge.
- I live at 5518 Swiss Avenue, Dallas, Texas, 75205 since 1999 and I am only one house separated from the Aldredge House.
 - 3. I have lived in the Swiss Avenue Historic District ("SAHD") since 1987.
- 4. My husband and I believe the Aldredge house is an asset to both the neighborhood and to our property specifically.
 - 5. I see the exterior of the Aldredge House daily.
- 6. The Aldredge House is maintained to perfection. You would be hard pressed to find a chip in its paint or a rogue blade of grass on its lawn.
- 7. We have never had trash left on our property as a by-product of one of the events that took place at the Aldredge House.
- 8. There has never been noise coming from the Aldredge House that has been a disturbance to us.

- 9. It has been our experience that any circulating trash comes from the over flowing dumpsters belonging to the apartments on Gaston Avenue and pedestrian traffic unrelated to the Aldredge House.
- 10. Trash removal has been a problem on our street because it gets stuck in the mud. Furthermore, at times the City had difficulty removing the trash because of the unpaved condition of the alley near my house and the Aldredge House. This situation has been remedied by the City and things are much better.
- 11. There are many noises associated with the alley. The trucks that dump the trash in the dumpsters were loud, but they no longer come in the early before dawn hours. The air conditioning units from the apartment complexes on the street are old and loud, but the Aldredge house has not been the problem.
- 12. I have heard an occasional toast, laughter, and happy music coming from the Aldredge House. On rare occasions, I have heard bag pipes from the Aldredge House. However, the sounds coming from the Aldredge house are no louder than the other sounds coming from our neighbor's parties and parties hosted from our own house. We would never want our neighbors to stop having parties.
- 13. We have had a few cars occasionally parked in front of our house from guests of the Aldredge House. The cars are never parked there for more than a few hours. We have had other cars parked in front of our house from other neighbors' parties that were there for days. We knew this parking situation would occasionally occur when we bought our house and thus it was not a surprise.
- 14. We live in the "heartbeat" of the neighborhood. Every Halloween, we have thousands of children who Trick-or-Treat, and we also participate in the Swiss Avenue Page 2 of 4

Home Tour. The Whiterock Marathon also comes down Swiss Avenue. Our street is trashed after the marathon and there is screaming all day.

- 15. Conversely, the Aldredge House is a great neighbor and we are lucky to have them.
- 16. It would be extremely difficult for most private citizens to afford and maintain the Aldredge House to its current standards.
- 17. The Aldredge House provides a fabulous link representing the Swiss Avenue Historic District to people far outside our gates, giving them a look into the splendor that once existed through its architecture and gardens.
- 18. It would be a tremendous loss if the Aldredge House was no longer accessible to the public.
- 19. The Aldredge House has shown that it is willing to listen to its neighbors and work through issues; there is no need to pull the plug on a wonderful, historic Dallas institution.
 - 20. The City of Dallas should act as a steward to this Dallas treasure and protect it.


