### Landmark Aviation (SIC 4581)

Landmark Aviation is a fixed Based Operator facility specializing in aircraft service and support. This does not include removing and installing engines, avionics, interior design and installation. We do not perform major engine overhauls and does not participate in any deicing activities. Landmark aviation provides fueling services for general aviation aircraft. Waste fuel is kept in a containment area until picked up for disposal by an outside retrieval company. Chemical storage and lavatory fluids are kept in a covered containment area. There are no hangars, affiliated with Landmark Aviation at this time. There is a stormceptor than is located next to the ramp that intercepts water runoff. The stormceptor is serviced by an outside company on a scheduled annual basis and is monitored and recorded quarterly. Landmark Aviation, FBO, has in place an SPCC plan as required by regulations.

Employees are training in storm water pollution prevention and on the SPCC plan at time of hire with annual refreshers. All Line Service personnel are training in emergency response.

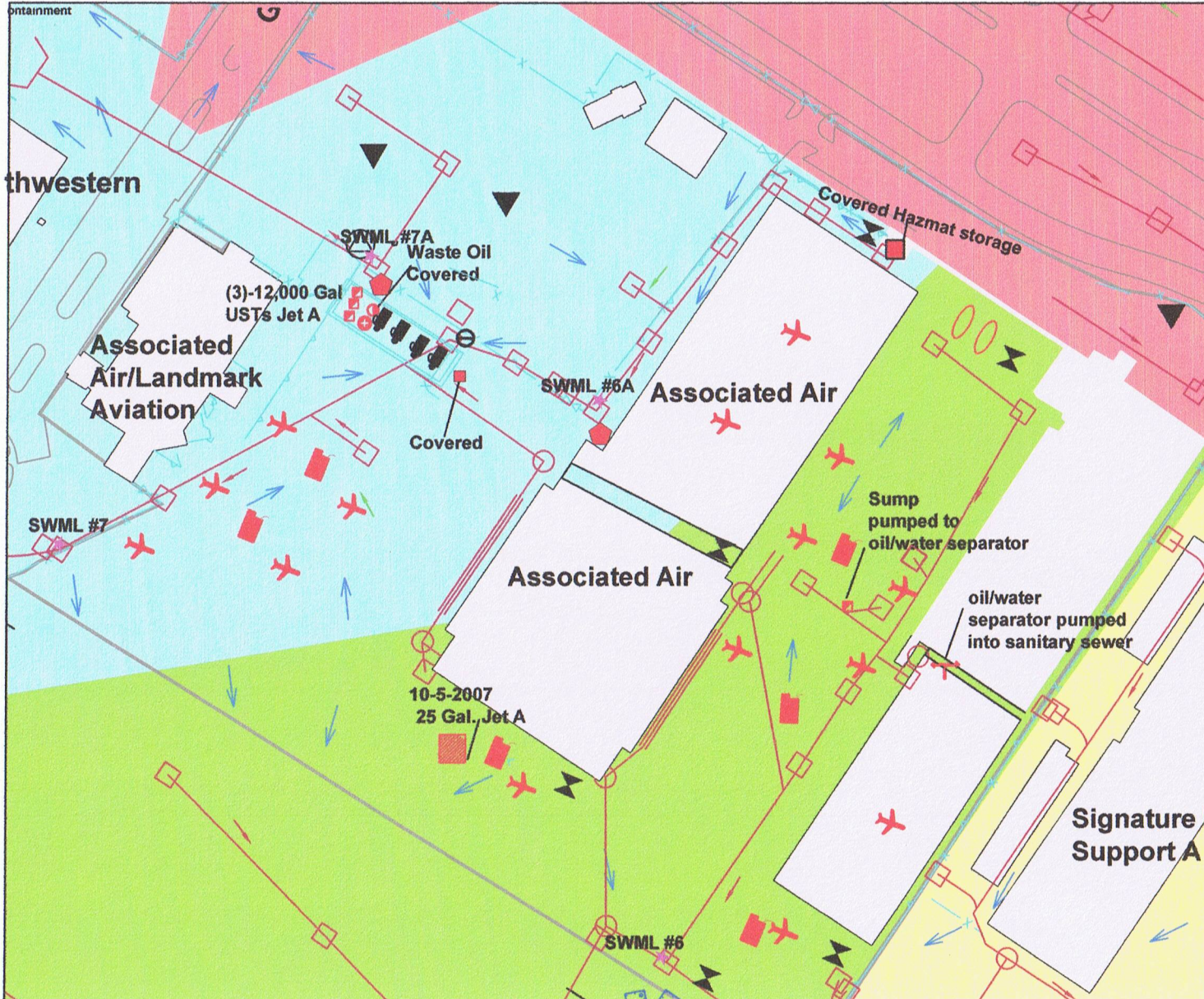

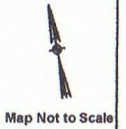
