The sub-committee, working with the Civil Service Staff and the City Attorney's Office, will review previous work products, problematic areas, and bring back to the full Board prioritized recommended rules changes.

Mr. Davis briefed the Board on various operational matters. He shared he was currently advertising for the Assistant Director of Civil Service. Upon questions and discussion regarding the position requiring a degree, Mr. Davis committed to working with HR to update the job description to allow for educational and experience equivalencies. Additionally, he provided updates about the office renovations and special projects with Human Resources to compile job descriptions for all City positions into a central database to assist with the compensation plan development and other integration efforts supporting implementing a new Human Resources Information System.

Chairman Dr. Troy Coleman designated Flora Hernandez to chair the May 9th Trial Board hearing of Russell Stowers. Adjunct panel members will be Calvin Robinson and Matthew Haynie.
